The Cinnamon Sugar retail box price from Plum Creek Foods is \$8.79/ea. Your organization will receive a 50% discount off the market retail price of the soft pretzels. This will allow you to keep 50% (or more) of the fundraiser proceeds. Your organization will choose the price at which to sell a box of soft pretzels to your customers. The minimum selling price is \$7.99/Original Box and 8.79/Cinnamon Sugar Box. There are no order minimum requirements!
RBJSL Report (<i>Cody</i>)	 Club Pass was voted on and passed by a large margin. SVYS voted no. Relegation Jan 21. Josh and Amy B met with RBJSL President and 2nd VP on Jan 21, 2025 to thoroughly discuss the "5 move rule" for spring rosters. RBJSL confirmed that no more than five players can be moved between the fall and spring seasons per team. This rule is strictly enforced by EPYSA, and there are no known avenues for a waiver. RBJSL will work with clubs to try to form valid rosters, but there is no exception to this rule. Therefore, the SVYS meeting minutes from Jun 2, 2024 concerning the transfer rule are reported in error. The information from those minutes is inaccurate and misleading. Please disregard those notes; this matter is now settled.
