



Liability Waiver

Tequio Foods, LLC
A North Carolina Limited Liability Company

This Liability Waiver, Assumption of Risk, and Release of Claims (the "Waiver") is entered into by the undersigned participant ("Participant," "I," or "me") in favor of **Tequio Foods, LLC**, its owners, members, managers, employees, contractors, agents, guides, hosts, partners, affiliates, successors, and assigns (collectively, the "Released Parties").

By signing this Waiver, I acknowledge and agree as follows:

1. Assumption of Risk

I understand and acknowledge that participation in trips, experiences, events, and activities organized by Tequio Foods, LLC (the "Activities") involves **inherent and significant risks**, whether foreseen or unforeseen, including but not limited to:

- Travel by aircraft, vehicle, boat, or other transportation
- Walking, hiking, standing for extended periods, or physical exertion
- Exposure to unfamiliar environments, food, weather, terrain, and facilities
- Alcohol consumption
- Illness, including communicable and foodborne diseases
- Acts or omissions of third parties, including suppliers and other participants
- Accidents resulting in injury, illness, permanent disability, or death

I knowingly, voluntarily, and expressly **assume all risks** associated with participation in the Activities, including risks arising from the negligence of the Released Parties, to the fullest extent permitted by law.



2. Health Representation

I represent and warrant that:

- I am at least **18 years of age**
- I am physically and mentally capable of participating in the Activities
- I have disclosed any relevant medical conditions, allergies, dietary restrictions, or limitations to Tequio Foods, LLC prior to participation

I understand that Tequio Foods, LLC is not responsible for providing medical care and assumes no responsibility for my medical treatment.

3. Release & Waiver of Liability

In consideration for being permitted to participate in the Activities, I hereby **release, waive, discharge, and covenant not to sue** the Released Parties from any and all claims, demands, causes of action, damages, losses, liabilities, costs, or expenses of any kind, whether known or unknown, arising out of or related to my participation, including but not limited to claims based on:

- Negligence
- Personal injury
- Illness or disease
- Property damage or loss
- Emotional distress
- Death

This release applies to the maximum extent permitted under North Carolina law.



4. Indemnification

I agree to **indemnify, defend, and hold harmless** the Released Parties from and against any and all claims, damages, losses, liabilities, costs, and expenses (including reasonable attorneys' fees) arising from:

- My participation in the Activities
 - My violation of any law, rule, or regulation
 - My breach of this Waiver or the Terms & Conditions of Travel
 - Any damage or injury I cause to others

5. No Responsibility for Third Parties

I acknowledge that Tequio Foods, LLC does not own or control third-party suppliers, venues, transportation providers, or activity operators. I agree that Tequio Foods, LLC is **not responsible or liable** for the acts, omissions, or negligence of such third parties.

6. Insurance Acknowledgment

I acknowledge that I am responsible for obtaining my own **health, medical, and travel insurance** and that Tequio Foods, LLC does not provide insurance coverage for participants.

7. Alcohol, Drugs & Conduct

I acknowledge that illegal drug use is strictly prohibited. I agree to consume alcohol responsibly and understand that impairment increases risk. I assume all risks associated with alcohol consumption during the Activities.

Tequio Foods, LLC reserves the right to remove any participant for unsafe or inappropriate behavior, without refund.



8. Photography & Media Consent

I grant Tequio Foods, LLC a **perpetual, worldwide, royalty-free license** to use my name, likeness, image, voice, and appearance in photographs, videos, and recordings taken during the Activities for promotional and marketing purposes, without compensation.

9. Governing Law & Venue

This Waiver shall be governed by and interpreted in accordance with the laws of the **State of North Carolina**. Any legal action arising from this Waiver shall be brought exclusively in state or federal courts located in North Carolina.

10. Severability

If any provision of this Waiver is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

11. Acknowledgment & Electronic Signature

I acknowledge that I have carefully read this Waiver, understand its contents, and understand that by signing, I am **waiving substantial legal rights**, including the right to sue.

I agree that my electronic signature is valid and binding and has the same force and effect as a handwritten signature.
