




Tools Needed


- 1/2in Wrench/Socket
- 3/8in Wrench/Socket


1. Attach the mounting bracket to the mower using the (4) provided self drilling/tapping screws or rivets at your desired location. Make sure to check behind the panel you are attaching to and avoid any mechanical or electrical components.




2. Mount the main Tri-Pod light assembly to the mounting bracket using the provided 2 carriage bolts (5/16-18 x .75in) and flange nuts. Level the light assembly and tighten the nuts/bolts so it does not move.



3. Using the provided zip ties, route the wiring to the battery of the mower and connect the red wire to the positive (+) terminal and the black wire to the negative (-) terminal. Make sure the wires avoid any moving parts that can pinch them and any engine parts that can get hot.



4. Install the steel side accessory mount plate to either side as shown. This can be used to add phone mounts and other accessories.

- 2. Products which have been subject to misuse, negligence, accident, improper installation, maintenance, care, or storage.
- 3. Dawson Manufacturing does not assume liability for damage to your equipment resulting from the attachment or use of any Dawson Manufacturing. Equipment risk is the sole responsibility of the purchaser.
