Sophia never loses sight of her ability to skilfully turn the audience's gaze upon itself.

Sophia is committed to the evolution of the script and has taken on board my feedback with excitement and rigour. Throughout my time knowing her she has always been open to having dialogue about her work and is eager to have her ideas challenged in order for the work to thrive. I understand the work has already undergone some professional development with actors and the script is ripe for production. I wholeheartedly believe this play is going to be a success when it hits the stage in October and will delight and inspire audiences in Adelaide and hopefully reach a wider audience in the future. Sophia's work is timely, her voice is new and exciting and she in an artist worth backing. In 2015, I directed a week of developments and a rehearsed reading of *Limit* as a part of Playwriting Australia's Home Grown program in the National Play Festival. The assistant director assigned to me on that project was Shannon Rush. Later that year I got to work with Sophia again as an actor when I directed her in *Middletown* at AC Arts.

*Limit* is a smart play that speaks to the here and now, but also asks bigger questions of us as the human species. It is particularly relevant for South Australia presently with the forthcoming space agency to be established here, and globally with the work of Space X and other private enterprise space focussed companies.

The play also asks questions of humanity's need to explore, what it means to leave everything you know, the future of humanity, and who we are as humans.

Working on Limit in 2015, I found both Sophia and Shannon to be intelligent artists with a keen sense of story, drama and dramaturgy. Shannon's suggestions and ideas in the rehearsal room were always welcome, relevant and insightful. Sophia's responses to provocations and suggestions from Dramaturg Nicki Bloom and myself, were considered, perceptive and brave.

I have had the good fortune to work with both these passionate, talented women.

I taught Ms Simmons throughout her three years of acting study at Adelaide College of the Arts. She was at all times a dedicated student, a compassionate and greatly loved class member, and an artistic leader. I had the please of directing her in her graduating year in the leading role of Beatrice in *Much Ado About Nothing.* She gave a performance of high professional standard and was an inspiring leader throughout.
