This Declaration of Fourth Amendment of the Declaration of Restrictions of Cambridge Estates (Planned Development) is made by the Cambridge Estates Homeowners Association, a California non-profit mutual benefit corporation ("Association"), in reference to the following facts:

Recitals

A. Association is formed and existing under the laws of the State of California to manage the Cambridge Estates Subdivision under that certain Declaration of Restrictions of Cambridge Estates recorded as Instrument No. 92-27533 in the Official Records of Nevada County, California (the "Declaration"), pursuant to section 6.01 of the Declaration.

B. Section 15.02 of the Declaration permits amendment of the Declaration by a vote of the members of the Association.

C. The Association has put to a vote of the members a proposed amendment to sections 4.10 of the Declaration, and the proper number of members voted in favor of adopting the proposed amendment.

D. Pursuant to Section 15.03 of the Declaration, the Association now intends to record the amendment to the Declaration approved by the members of the Association.

NOW, THEREFORE, Declarant declares as follows:

1. Section 4.10

Section 4.10, Subparagraph L is amended by deleting that section in its entirety and replacing it with the following:

4.10 L. Landscaping. Native plants and/or drought tolerant plant species are encouraged, although not required, to be used for landscaping around proposed residences. Owners are encouraged, but not required, to retain existing Jeffery Pines where possible and other naturally occurring vegetation.


2. Incorporation by Reference. The provisions of the Declaration, except as expressly amended herein, are incorporated herein by this reference, and are expressly declared to be applicable to the Real Property, as described in Section 1.01 of the Declaration, and all real


property annexed to the Declaration, pursuant to Section 3.03 of the Declaration. Except as otherwise provided herein, all capitalized terms used in this Declaration of First Amendment shall have the same meanings as set forth in the Declaration.

3. Effective Date. This Declaration of Fourth Amendment is effective as of October 10, 2006, the date of its certification by the Association Secretary as having been regularly and duly adopted.

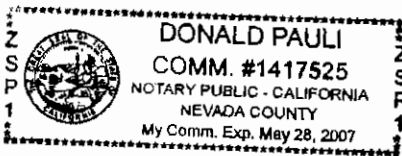
