INITIALS _____ Your dog must be healthy and current on all vaccinations. It is your responsibility to provide documentation before or at the initial visit and to also provide updated documentation as needed. For the safety of all our canine guests, we reserve the right to refuse service for any pet that is showing an expired vaccination in our files.

INITIALS _____ **Bordetella Vaccine** - If your pet is a regular at daycare, grooming and Boarding facilities or the dog park, those shots every 6 to 12 months to help prevent canine infectious tracheobronchitis (aka kennel cough) may be inconvenient, but the vaccine against Bordetella is important in order to protect your pet from the hacking cough and snotty nose brought on by the easily contracted bacteria that causes the highly contagious disease in both dogs and cats. The vaccine does NOT prevent Kennel Cough it makes it a lesser case of it so it is not as bad. The vaccine is like you getting a flu shot. The flu shot does NOT prevent the flu it only makes it so its not as bad of a case. I understand that the Kennel Couch Vaccine (Bordetella) is not state required but is highly recommend by Tracy's Doggone Farm L.L.C.. I understand the risk that if I board my dog/cat without the Bordetella Vaccine there is a chance that my dog/cat may come down with Kennel cough. We strongly encourage that you vaccinate your dog or cat with the Bordetella vaccine. Even though dogs/cats may not appear to be sick, some may be a carrier of Kennel Cough that can be spread to others.

INITIALS _____ **Canine Influenza Vaccine** - Canine influenza (also known as dog flu) is a contagious respiratory disease in dogs caused by specific Type A influenza viruses known to infect dogs. These are called "canine influenza viruses." Dog flu is a disease of dogs. No human infections with canine influenza have ever been reported. There are two different influenza A dog flu viruses: one is an H3N8 virus and the other is an H3N2 virus. Almost all dogs are susceptible to canine flu infection, and illness tends to spread among dogs housed in kennels and shelters. Canine flu can spread to other dogs by direct contact with aerosolized respiratory secretions (coughing and sneezing) from infected dogs, by uninfected dogs coming into contact with contaminated objects, and by moving contaminated objects or materials between infected and uninfected dogs. Therefore, dog owners whose dogs are coughing or showing other signs of respiratory disease should not expose their dog to other dogs. I understand that the Canine Influenza Vaccine (Dog Flu) is not state required but is highly recommend by Tracy's Doggone Farm L.L.C.. I understand the risk that if I board my dog without the Canine Influenza Vaccine there is a chance that my dog may come down with the Dog Flu. We strongly encourage that you vaccinate your dog with the Canine Influenza vaccine. Even though a dog may not appear to be sick, some may be a carrier of Canine Influenza that can be spread to others.

You know your pet best, when they come in we do not know them the way you do so if they are acting "off" please let us know that way we can monitor them properly.
