Express Entertainment Rental Agreement

Lessee Eligibility

Lessee must be 21 years of age or older. Valid identification must be provided prior to Lessee boarding the bus.

Lessee Responsibility

The Lessee is responsible for all activities of the passengers aboard the bus. This includes any conduct that could result in legal action taken on behalf of Express Entertainment.

Rates & Fuel Charge

Rates and fuel charges are determined by the administration of Express Entertainment based on time and distance of the lease. Discounted rates are considered a case by case basis, and are at the sole discretion of Express Entertainment and its marketing strategy.

Deposit

Deposits are accepted via cash, check, paypal, debit, or credit card. Deposits that warrant a refund are solely at the discretion of Express Entertainment. In the event of severe weather or a cancellation on behalf of Express Entertainment, a refund will be deemed necessary for all funds including deposit. Severe weather is considered an official "Severe Weather Warning" issued by any local television network or the National Weather Center.

Payment

Full payment must be received prior to boarding the bus. Acceptable payments are certified check, money order, or credit card.

Cancellation Policy

All cancellations must be made 48 hours prior to the event date. Deposits are not refundable under the cancelation policy.

Damage Assessment

If there is any damage to the bus or excessive cleanup is required, a damage assessment will be made and additional charges may be placed upon the Lessee to cover the cost. Any damage assessment will be determined once the bus has returned to the shop and has been thoroughly cleaned.

There is a \$100 cleaning surcharge for vomit incidents

Personal Items

Express Entertainment is not responsible for lost, damaged, or stolen property. We ask that all guests remove all valuables from the bus anytime they exit the bus.
