SECTION 2 - ADDITIONAL VICTIMS / MISSING PERSONS

Note: In or around September 2022 — the same month the described events at 420 N Camden Drive commenced — the following individuals all disappeared without explanation or became unreachable. Their concurrent disappearances are characterized by the Subject as potentially interconnected and are each treated herein as matters requiring immediate law enforcement attention.

Friend, business partner, and romantic partner; introduced to Sprawling by suspect Kyle Joseph Egan

Last Known Location

420 N Camden Drive, Beverly Hills, CA 90210

Investigative Notes

Last contact with Sprawling occurred at 420 N Camden Drive. During final in-person visit, Vetter expressed significant fear of being monitored and physically searched Sprawling's apartment for hidden cameras. Vetter subsequently became unreachable and all contact ceased without explanation, despite having made concrete future plans with Sprawling, including plans to live together and collaborate on film projects. Vetter had previously disclosed to Sprawling that suspect Egan was

involved in the sexual exploitation of friends and associates. Sprawling was informed that recordings of his relationship with Vetter were sold as pornographic material without their informed consent. Vetter's identity could not be independently verified following his disappearance.

Circumstances of Disappearance

Disappeared on the same day he had made plans to visit Sprawling at 420 N Camden Drive. When Sprawling contacted Egan to report the vehicles and individuals on foot harassing him, Egan responded:

"Is this how you say sorry."

Egan had previously reported to others that Sprawling was suffering from mental illness and methamphetamine psychosis — allegations directly contradicted by medical and laboratory testing.

Missing Person 3 — Spiro, Yuri Richard (Landlord)

Landlord of 420 N Camden Drive, Beverly Hills, CA 90210; had previously described Sprawling as "family" and, as his only tenant and primary source of investment income, possessed unambiguous knowledge of Sprawling's correct legal identity.

Circumstances of Disappearance

Disappeared approximately concurrent with the onset of incidents described herein in September 2022. His disappearance is characterized by the Subject as potentially connected to the broader scheme. Spiro filed a complaint resulting in a false arrest of Sprawling under an incorrect name, as described in Section 8 of this report. Known associate: Sean Richard Spiro.

Victim reported the full scope of the abuse to Dr. Heafey during therapeutic sessions. No follow-up action or cooperation with law enforcement was initiated by

Dr. Heafey following these disclosures.

SECTION 4 - NARRATIVE SUMMARY

The following narrative is reported in the third person as provided by the reporting victim, Rodney Samuel Sprawling. All facts are stated as alleged by the complainant and are subject to independent investigation. This report does not constitute a finding of fact or a determination of guilt.

4.1 — Onset of Surveillance and Stalking

In September 2022, following a visit to Sprawling's residence and place of business at 420 N Camden Drive, Beverly Hills, CA 90210 by suspect Kyle Joseph Egan, Sprawling began observing vehicles and individuals on foot conducting what appeared to be deliberate and coordinated surveillance of the property. This surveillance was persistent and continued over an extended period. The nature of the surveillance, including its coordination and sustained duration, suggested to the victim that it was organized rather than opportunistic.

4.2 — Communication Interference and Forced Isolation

Shortly after the surveillance began, Sprawling experienced systematic interference with his communications. He became unable to contact his husband, Andrei George Dunca, and has not seen or heard from Dunca since the onset of the incident period. Sprawling was effectively placed in a state of forced isolation at 420 N Camden Drive, cutting him off from his personal support network and limiting his ability to seek outside assistance.

4.3 — Unauthorized Use of Building AV System / Psychological Coercion

Following the communication blackout, unknown individuals began utilizing the audio-visual (AV) system within the building at 420 N Camden Drive to communicate with Sprawling in what he characterizes as a "Big Brother"-style surveillance operation. Sprawling was subjected to a sustained campaign of psychological manipulation, intimidation, and what he characterizes as enhanced interrogation-style techniques conducted remotely via this building system. The use of this infrastructure implies access to and control over the building's internal systems by the perpetrating parties.

4.4 — Coerced Sexual Acts and Documented Exploitation

Through the use of these coercive techniques, Sprawling was manipulated and terrorized into performing sexual acts. He was informed by the perpetrators that these acts were being recorded without his meaningful consent. The victim was threatened that recordings would be publicly released if he attempted to report the abuse or seek assistance from law enforcement or others. These threats were specifically designed to exploit Sprawling's professional ambitions as an actor and producer, with the intent of making him fear permanent career destruction as a direct consequence of any disclosure.

4.5 — Facilitated Sexual Contact and Production of Pornographic Material

During the period of isolation and coercion at 420 N Camden Drive, individuals whom Sprawling was made to believe were controlled by the perpetrating group were permitted to make physical contact with him for purposes of sexual encounters. These encounters were documented without Sprawling's informed consent, and Sprawling was subsequently informed that recordings of these encounters were sold as commercial pornographic material. The non-consensual nature of these

recordings constitutes a distinct and separate criminal act from the underlying sexual offenses.

4.6 — Statements and Admissions Regarding Suspect Kyle Joseph Egan

Suspect Kyle Joseph Egan is documented as having admitted to producing rape fetish pornography prior to and during the incident period. Egan enlisted his fiancé, Kory Lamar Ward, and other individuals to participate in the production of videos depicting simulated rape scenarios for commercial sale to private collectors. These admissions are considered directly relevant to the pattern of criminal conduct alleged in this report and establish a documented predisposition on the part of Suspect Egan toward the production and distribution of non-consensual or coerced sexual content.

4.7 — Victim Richard Alan Vetter: Sexual Exploitation and Disappearance

Richard Alan Vetter, introduced to Sprawling by Egan during the Beverly Hills incident period, developed both a romantic and business partnership with Sprawling. Sprawling was informed that his relationship with Vetter was documented and that recordings of the two were sold as pornographic material without their informed consent. Vetter had previously disclosed to Sprawling that Egan was involved in the sexual exploitation of friends and associates. During Vetter's last in-person contact with Sprawling at 420 N Camden Drive, Vetter expressed significant fear that he was being watched and followed, and physically inspected Sprawling's apartment for hidden recording devices. Vetter subsequently disappeared, all contact ended, and Sprawling has been unable to reach Vetter or independently verify his whereabouts or wellbeing. The circumstances of Vetter's disappearance are treated herein as a matter requiring immediate law enforcement attention.

4.8 — Suspect Egan's Suspicious Communications with Victim

On the same day that suspect Kyle Joseph Egan had made arrangements to visit Sprawling at 420 N Camden Drive, Egan failed to appear and subsequently disappeared. When Sprawling contacted Egan to report the vehicles and individuals on foot surveilling and harassing him at the Camden Drive address, Egan responded with the following message: **"Is this how you say sorry."** This communication is documented by the victim and is considered significant to the investigation in light of its content, timing, and context. Preservation of this electronic communication record is requested as a priority investigative action.

4.9 — Coordinated Campaign to Discredit the Victim

A coordinated effort was made by individuals connected to the suspected perpetrating group to discredit Sprawling and undermine any reports he made to law enforcement or his personal network. Specifically, false allegations were disseminated within Sprawling's professional and personal network — attributed in part to suspect Egan — claiming that Sprawling was experiencing a mental health crisis and psychosis resulting from methamphetamine use. These allegations are categorically denied by Sprawling and are directly contradicted by objective medical evidence, including assessments conducted by Dr. Naheed Ali and drug testing through Quest Diagnostics, as detailed in Section 5 of this report.

SECTION 5 - MEDICAL AND PSYCHOLOGICAL EVALUATION (SUPPORTING DOCUMENTATION)

5.1 — Primary Care Physician: Dr. Naheed Ali

During the period of forced isolation at 420 N Camden Drive, Sprawling contacted his primary care physician, Dr. Naheed Ali. Dr. Ali conducted multiple in-person, in-home assessments at the Camden Drive address. All assessments by Dr. Ali documented that Sprawling was "otherwise sane," not suffering from auditory or visual hallucinations, and was cognitively intact. A full-panel drug test conducted

through Quest Diagnostics confirmed that Sprawling tested negative for all illicit substances during the period in which false reports of drug use and mental incapacity were being disseminated to his personal and professional network and to law enforcement.

5.2 — Referral for Psychological Assessment

Dr. Ali recommended that Sprawling obtain a formal psychological assessment to provide independent documentation of his mental competence, expressing concern that law enforcement would otherwise be unable to assist him in the absence of such documentation. At Dr. Ali's recommendation, Sprawling contacted psychologist Dr. Richard Austin Heafey for the purpose of this independent psychological assessment.

5.3 — Disclosure to Dr. Richard Austin Heafey

Sprawling disclosed the full scope of the abuse described in this report to Dr. Richard Austin Heafey during their therapeutic sessions. No follow-up action was taken by Dr. Heafey in relation to these disclosures, and no coordination with law enforcement was initiated by him. Given the nature of the disclosures made — including allegations of ongoing rape, sexual exploitation, coercion, and a missing person — the absence of any mandatory reporting action by Dr. Heafey is noted and may warrant separate review by the applicable licensing authority.

SECTION 6 - PRIOR REPORTS TO LAW ENFORCEMENT

6.1 — Beverly Hills Police Department — Detective Geoff

Sprawling previously reported the incidents described in this report to the Beverly Hills Police Department. His contact included interaction with a detective identified as "Det. Geoff." Sprawling noted that during this interaction, responding officers appeared to treat him as an individual suffering from mental illness or drug-related symptoms rather than as a credible crime victim making a good-faith report. No

investigation was opened as a result of this prior report, and no follow-up contact was made by BHPD investigators.

6.2 — Absence of Investigation

To date, no law enforcement investigation has been formally opened, no suspect named in this report has been interviewed by police, no evidence has been collected or preserved, and no charges have been filed in connection with the incidents described herein. This report is submitted to formally renew the complainant's request for investigation and to provide a comprehensive record of all alleged offenses for law enforcement review.

SECTION 7 - CRIMES ALLEGED

The following criminal offenses are alleged by the reporting victim in connection with the incidents described in this report. Each is cited with the applicable California Penal Code section where relevant:

- **Rape** — California Penal Code § 261
- **Sexual Exploitation / Coerced Production of Pornographic Material** — Non-consensual recording and commercial distribution of sexual acts
- **Stalking** — California Penal Code § 646.9
- **Criminal Threats** — California Penal Code § 422
- **False Imprisonment / Forced Isolation** — California Penal Code § 236
- **Conspiracy to Commit the Above Offenses** — California Penal Code § 182
- **Sexual Extortion (Sextortion)** — California Penal Code § 647(j)(4)
- **Human Trafficking** — California Penal Code § 236.1 — *Referred for Investigation*
- **Unauthorized Access to Building Systems / Electronic Surveillance** — California Penal Code § 502; California Penal Code § 632

SECTION 8 - REQUESTED INVESTIGATIVE ACTIONS

The reporting victim respectfully requests that the following investigative actions be taken as a matter of urgency:

- 1. Immediate welfare check and formal missing persons investigation for Richard Alan Vetter, last known contact at 420 N Camden Drive, Beverly Hills, CA 90210.**
- 2. Interview of suspect Kyle Joseph Egan regarding documented admissions related to pornographic content production, his relationship with the victim, the documented electronic communication ("Is this how you say sorry"), and his knowledge of and involvement in events at 420 N Camden Drive.**
- 3. Interview of Dr. Richard Austin Heafey regarding disclosures made by Sprawling during therapeutic sessions and any records, notes, or observations from those sessions, subject to applicable legal process.**
- 4. Subpoena and forensic examination of building audio-visual system records at 420 N Camden Drive, Beverly Hills, CA 90210, including access logs, user records, and any stored recordings.**
- 5. Collection and preservation of electronic communications records between Sprawling and Egan, including but not limited to the documented message: *"Is this how you say sorry."***
- 6. Coordination with Dr. Naheed Ali and Quest Diagnostics to obtain, authenticate, and preserve medical assessment records and full-panel drug test results confirming victim's mental competence and sobriety during the incident period.**
- 7. Review and preservation of all available surveillance footage from 420 N Camden Drive, surrounding streets, and neighboring properties, for the period beginning September 2022 through the present.**

8. **Investigation into the production, distribution, and commercial sale of non-consensual pornographic recordings described in this report, including identification of platforms, distributors, and purchasers.**
9. **Retrieval of prior BHPD report and case notes from the interaction involving "Det. Geoff" to establish a complete prior-report record and assess prior handling of the complainant's disclosures.**
10. **Assessment of referral to the Los Angeles County District Attorney's Office, Human Trafficking Task Force, and California Department of Justice as warranted by investigative findings.**
