

**SECOND NOTICE OF ANNUAL MEETING
BOCA LAKES CONDOMINIUM ASSOCIATION, INC.**

TO ALL MEMBERS:

On Thursday, February 12, 2026 at 7:00 P.M., at the Boca Lakes Clubhouse, located at 8768 Chevy Chase Drive, Boca Raton, FL 33433, the Annual Meeting of Boca Lakes Condominium Association, Inc. (the "Association") will be held. An identification of agenda items is as follows:

1. Calling of the roll and certifying of proxies;
2. Proof of notice of meeting or waiver of notice;
3. Reading and disposal of any unapproved minutes;
4. Reports of officers;
5. Reports of committees;
6. Election of Directors – N/A;
7. Unfinished business;
8. New business;
9. Adjournment.

A majority of the votes of the entire membership of the Association (a "quorum") must be present, in person or by proxy, at the meeting in order for the business of the meeting to be conducted. Pursuant to Florida Law, an election of the directors of the Association is not required, since the number of eligible candidates that timely submitted a notice of intent to run for the Board was less than or equal to the number of vacancies to be filled. The eligible candidates who will be deemed elected at the Annual Meeting to serve for a two (2) year term are Luann Biancardi, Patricia Chapman and Neana (Sue) Longtin.

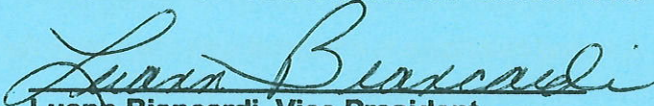
Enclosed with this Notice are proxy instructions, voting certificate instructions, a General Proxy to establish a quorum only to conduct the annual meeting, a Voting Certificate in the event your Unit is owned by more than one person (excluding a married couple) or a corporation, as well as the Information Sheets prepared and timely submitted by the candidates named above who will be serving on the Board. The candidates are solely responsible for the contents of their statements. The Association is transmitting this information in accordance with the requirements of Florida Law; however, the Association is not in the position to verify the accuracy of the information or statements contained therein, and disclaims any responsibility for the information contained within the Information Sheets.

Immediately following the Annual Meeting, the Board of Directors will conduct an Organizational Meeting. The agenda for the Organizational Meeting of the Board is as follows:

- B. Proof of Notice;
- C. New Business:
 - (i) Elect officers
 - (ii) Designate authorized signatories on the Association's bank accounts
- D. Adjournment.

PROXY INSTRUCTIONS

If you are unable to attend the Annual Meeting in person and wish to return the proxy for quorum purposes only, please note the following information:

1. A **proxy** must be signed by the owner or voting representative of the Unit. If a Unit is owned by more than one person (excluding a married couple), the person entitled to cast the vote for the Unit shall be designated in a certificate, signed by all of the recorded owners of the Unit and filed with the Secretary of the Association. If a Unit is owned by a corporation, the officer or employee thereof entitled to cast the vote of the Unit for the corporation shall be designated in a certificate, signed by the President or Vice President and attested to by the Secretary or Assistant Secretary of the Corporation, and filed with the Secretary of the Association.
2. The proxy should be submitted to the Association **prior to the scheduled time of the meeting** if you designate the Secretary as your proxy holder. It can be hand-delivered, either by you or your proxy holder, or mailed to the Association at: **8768 Chevy Chase Drive, Boca Raton, FL 33433**. In order to avoid delay in registration, it is encouraged that the proxy be submitted as long before the meeting as possible.
3. **If you designate an owner as your proxy holder that owner must attend the meeting with your proxy.** If you appoint a proxy and later decide to attend the meeting in person, you may **withdraw** your proxy when you register at the meeting.
4. A proxy may be **revoked in writing, superseded** by a later dated proxy, or **assigned** (substituted) by the person designated on the proxy to a third person if the person you designate as proxy decides that he or she will be unable to attend the meeting.
5. A proxy form is enclosed with this notice for your use, if needed.

VOTING CERTIFICATE INSTRUCTIONS

Pursuant to Article II Section 5 of the Bylaws of Boca Lakes Condominium Association, Inc., Voting Certificates are required under the circumstances described in these instructions below. A voting certificate is being provided to determine who the voting representatives will be for your Unit if your Unit is owned by more than one person (excluding a married couple) or a corporation. Please note the following information about **VOTING CERTIFICATES**:

- 1) A voting certificate is not needed only if the unit is owned by **only one person**.
- Note: See Exhibit "A" attached hereto regarding whether a voting certificate is needed for a married couple.
- 2) A voting certificate is not a proxy and cannot be used as such. Only an owner or the appropriate corporate officer can be named on a voting certificate, not a third party.
 - 3) A voting certificate must be signed by all of the owners of the unit or the appropriate corporate officer.
 - 4) A voting certificate is enclosed with this notice for your use, if needed.

Exhibit "A"

VOTING CERTIFICATE

If a Unit is owned jointly by husband and wife, the following three provisions are applicable thereto:

- (a). They may, but they shall not be required to, designate a voting member.
- (b). If they do not designate a voting member, and if both are present at a meeting and are unable to concur in their decision upon any subject requiring a vote, they shall lose their right to vote on that subject at that meeting. (As previously provided, the vote of a Unit is not divisible).
- (c). Where they do not designate a voting member, and only one is present at a meeting, the person present may cast the Unit vote, just as though he or she owned the Unit individually, and without establishing the concurrence of the absent person.
