This Statement of Work (hereinafter called "SOW" is issued pursuant to and between ("Clients") and STATE OF SCNRFP, effective immediately upon date signed (the "Agreement").

This SOW is subject to the terms and conditions contained in this agreement between the parties.

SOW# _____, effective as of _____, is entered into by and between STATE OF SCNRFP and the Client and is subject to the terms and conditions specified below. The Exhibit(s) to this SOW, if any, shall be deemed to be a part hereof.

INSURANCE

SOW Insurance Policy # _____

Insurance policy number will be assigned when the amount of transport, departure and arrival are provided. It will be provided at the time of pickup for security purposes.

SAFE KEEPING RECEIPT (SKR)

SKR# _____ Shall be provided to the Identified Departure Person at the time of pickup and provided to the Identified Arrival Person at the time of delivery.



In the event of any inconsistency between the terms of the body of this SOW and the terms of the Exhibit(s) hereto, the terms of the body of this SOW shall prevail. Note: STATE OF SCNRFP Shall do what is legally necessary to secure and protect the valuables being transported to include but not be limited to varying as necessary from the planned route.

Security Deposit

Client shall wire to STATE OF SCNRFP Major Account or STATE OF SCNRFP Correspondent Account or STATE OF SCNRFP Nostro Account a minimum amount of \$ _____ in "Good Faith" to activate this contract. Deposit shall be made prior to any services being provided. Cash will also be acceptable. A trust account shall be established for the client to deposit total funds within an established international bank licensed by the State of SCNRFP, followed by the client becoming eligible for a bank license by the State of SCNRFP, if the client desires to operate a bank. In the event a cash deposit is to be made instead of a wire deposit, STATE OF SCNRFP shall send over a STATE OF SCNRFP/State of SCNRFP representative to receive the cash deposit, at which time STATE OF SCNRFP shall provide a receipt for said deposit. Said deposit shall be in the amount of ____% (TBD). Transportation contracted shall be either a diplomatic attaché mission or a non-diplomatic transportation, choice is made by the client and transportation deposit will be adjusted according to which the client chooses. If diplomatic attaché is chosen, the package will not have to go through any customs, will not have any taxation, will not have to be reported legally, nothing has to be disclosed and will not be disclosed. All transportation is secure, licensed, bonded, insured, and armed team. If transportation is a diplomatic attaché transport, said transport will also be under a proper diplomatic mission and will be accompanied by an ambassador with proper credentials. Full and complete details will be required to perform said transportation planning and derive to a deposit charge and in order to establish a diplomatic attaché transport. Physical location address, weight, dimensions, container details, color, markings, any present or possible security dangers, location of nearest airports or private landing areas, if package will need to be brought to an airport by our team or if this will be conducted by the client. If cash, client will need to declare whether the cash is registered or not registered, and provide a complete proof of life, if cash package will need to be counted by the client obtaining a counter such as an accountant to count and sign off on the count and said count also signed by the principal or their official power of attorney with a document signed by the principal making third party a power of attorney and or mandate to conduct the said activities and say third party's authorization must be notarized, followed by a proper seal placed on the package, seal needs to remain intact until arrival of destination.

As of April 30, 2023 we are no longer charging a fee but rather a refundable deposit for diplomatic transportation, thus no charge for diplomatic transportation and deposit is will be refunded, unless we arrive and funds are not there, or they do not allow funds to be moved, or they back out of the transportation arrangements whereby we are out of pocket for making said arrangements, then the deposit will not be refundable, otherwise at proper completion of transport services deposit will be refunded, therefore no charge for diplomatic transportation services.

If Client decides to wire said deposit the account is as follows:



TRUST AGREEMENT PACKAGE

For purposes of jurisdiction, Client shall sign a trust agreement in the form attached as an exhibit which will terminate upon delivery by STATE OF SCNRFP of the valuables entrusted to it at the destination, unless client shall require ongoing services, in which case, said trust agreement shall remain in effect.

PERIOD OF PERFORMANCE

The Services shall commence on date and time agreed by and between the parties to this agreement and shall continue through until all agreed upon contractual obligations are completed, with an expected project completion date and time agreed to separately by and between the parties. For security purposes the dates and times are not made mention in this agreement and will only be confirmed by and between the Identified Departure Person and the Identified Arrival Person, which shall remain nameless in this agreement. A separate document of confirmation shall be made by and between the Identified Departure Person and STATE OF SCNRFP for security purposes.

SCOPE OF WORK

STATE OF SCNRFP shall provide the Services and Deliverable(s) as follows:

STATE OF SCNRFP agrees to provide and perform friendly society, international valuables transport services, diplomatic courier, and a STATE OF SCNRFP account, as may be contracted by the Client, and may otherwise include but not be limited to: secure cash transportation, and business to cash vault delivery at the client's direction and acceptance of STATE OF SCNRFP. No other services such as STATE OF SCNRFP depository, account services nor diplomatic courier services have been requested at this time. Secure transportation services of valuables only have hereby been contracted at this time.

DELIVERABLE MATERIALS

STATE OF SCNRFP agrees to deliver a completed, personalized, detailed Arrival Service Notice to the client upon delivery. In the event further services are required, STATE OF SCNRFP will deliver the following reports in the below listed fashion:

1. The reports shall cover the time and date of service for Client locations.
2. The reports shall cover the gross amount of valuables moved from Client's location.
3. The reports shall cover the gross amount of valuables deposited into the Clients' accounts.

CLIENT RESPONSIBILITIES

1. The Client shall ensure that the STATE OF SCNRFP has timely, unfettered access to their site.
2. The Client shall ensure that the STATE OF SCNRFP has the current codes or keys to access sites if necessary to secure transport.
3. The Client shall ensure that an identifiable person or an identifiable entity with fiduciary responsibilities handles all valuables being transferred. All identifiable persons shall go through our internal affairs division. All Clients and Parties in concert with Client in said contracted transaction and transportation shall go through our internal affairs, and honor matters covered under Basel III such as anti-money laundering, anti-fraud, anti-terrorism and otherwise, and provide KYC for each Client and Receiving entity,



to include but not be limited to a color copy of a driver's license and passport, with all information being current.

4. The clients shall notify STATE OF SCNRFP of any changes to the pick-up, deposit or transfer schedule. It requests a minimum of 48 hours before scheduled arrangements, if any changes are made other than Act of God. If this procedure is not followed, the STATE OF SCNRFP reserves the right to terminate its service, in which case the minimum fee (deposit) shall be fully earned.

FEE SCHEDULE

This engagement will be conducted on a US cash dollars basis, at the request of the Client, payable at time of delivery minus said good faith deposit.

STATE OF SCNRFP will provide a highly trained professional agency team for the transaction and transport. A STATE OF SCNRFP transport specialist will have the ability to sign for the security deposit and refund (refund long as the transaction is completed and placed into State of SCNRFP Reserve Bank, otherwise there is no refund) along with regular signatures in the assigned cash book or pickup register.

Any change to this amount must be agreed upon in writing, prior to any contracted services being performed, a memo to the contract would then have to be issued specifying the amended value.

STATE OF SCNRFP will provide experienced, certified and professional highly trained physical transport specialist personnel to conduct point to point valuables transport and agreed upon gross amount valuables transfer services.

COMPLETION CRITERIA

STATE OF SCNRFP shall have fulfilled its scheduled obligations when any one of the following first occurs:

When the STATE OF SCNRFP accomplishes the activities described within this SOW.

PROJECT CHANGE CONTROL PROCEDURE

The following process will be followed if a timely change to this SOW is required:

Once transport has begun, no change (except for security purposes) will be acceptable. Prior to transport, if a change is requested, a written project change request (PCR) will be the means for communicating change. The PCR must describe the change, the rationale for the change, and the effect the change will have on the project. Said change shall be made within 14 days of the transport. Otherwise, Client shall forfeit the said good faith deposit.

The designated representative of the requesting party (STATE OF SCNRFP and Client) will review the proposed change and upon completion of review, both parties will present the impact of the proposed change and, if mutually agreed, a change authorization will be executed in writing and then carried out. The STATE OF SCNRFP shall reserve the right to make any changes necessary without review in order to secure and protect the contracted transport which at the time may be under attack or in jeopardy of loss.



This shall include but not be limited to while in transport. Sanctions shall be observed and the STATE OF SCNRFP respects points to Basel Accords.

The bank nor the account holder shall not conduct any military industrial complex transactions, deposits, funding, investment, or otherwise related with any government, nor by companies, nor individuals.
