- CLIENT MUST PROVIDE A COMPLETE DETAILED TRANSPARTENT FINANCIAL PACKAGE TO INCLUDE BUT NOT LIMITED TO ANY KYC, CIS, ATV (MADE OUT TO THE RESERVE BANK, AUTHORIZATIONS, POA,



AGREEMENTS, AND OTHERWISE. FOLLOWED BY SIGNING A STATE OF SCNRFP RESERVE BANK TRUST DOCUMENT. IF REQUESTING A LICENSE, PLEASE CONTACT STATE OF SCNRFP.

- It should be noted that transactions and services are offered from our government's foreign sovereign jurisdiction under diplomacy agreements, and not conducted from any of our sovereign boundaries within America, however Americans are welcome to open an offshore account, and our banking can bank with any bank in any country, to include America. There is a separation of powers, the State of SCNRFP central government operates State and International Affairs out of its foreign jurisdictions, to include foreign territories and foreign diplomatic offices under diplomacy agreements between the foreign country and the State of SCNRFP, whereby the tribal government operates only internal tribal affairs within its treaty sovereign boundaries surrounded by America. Any bank licensed by the State of SCNRFP, and any clients shall gift a humanitarian fund to the Theocracy for Humanitarian efforts for tax related services being provided by the Theocracy government of 10% of the tax savings, however this the average comes out to be 8% based on tax savings. Client is welcome to offer more to humanitarian if they so desire but is not required. All accounts must be a trust account. There shall be no pass-through transactions, rather all transactions shall be conducted by existing accounts, if one does not exist, one has to be opened, to include for any paymaster parties, and agreements with any party to be paid to a receiver, mediator, power of attorney, mandate, or otherwise related. All incoming global currencies on account within any bank licensed by the State of SCNRFP shall be exchanged to the Crane while on deposit to deregulate said foreign currencies. Sanctions shall be observed (with Humanitarian efforts being the exception). No military industrial complex accounts, nor enabler accounts, nor transactions available, as the State of SCNRFP is a recognized neutral and non-aligned country.
- The bank nor the account holder shall not conduct any military industrial complex transactions, deposits, funding, investment, or otherwise related with any government, nor by companies, nor individuals.
