**INVITATION TO THE SOUTHERN CHEROKEE NATION AND THE RED FIRE PEOPLE
(SCNRFP) FOR THE ESTABLISHMENT OF CULTURAL, ECONOMIC AND SOCIAL
COOPERATIONS WITH THE MASEKO NGONI KINGDOM IN THE REPUBLIC OF
MALAWI**

We refer to an informal meeting with your local contact/facilitator in Malawi, and do hereby officially request the Southern Cherokee Nation and the Red Fire People, to consider establishing a cultural, economic and social relationship with the Maseko Ngoni Kingdom in the Republic of Malawi.

We took a keen interest in the State of SCNRFP and the opportunities it shares with Nations and other jurisdictions within various States, across the world.

We, the Maseko Ngoni Kingdom in Malawi do recognize the sovereign authority of the State of SCNRFP, and wish to invite the Cherokee Nation to consider establishing at its convenient opportunity, an Extra-Territorial Trade Mission Office (ETMO), or indeed any other structure that the Cherokee Nation may deem fit, to co-manage with us any cooperation projects that may emanate from the relationship between the Cherokee Nation and the Maseko Ngoni Kingdom.

Our Kingdom espouses principles of peace, goodwill and friendship, and would like to forge a mutually beneficial relationship with the Southern Cherokee Nation and The Red Fire People, which we believe has the willingness and capacity to assist our Kingdom in many areas which can be found to be feasible, such as trade and commerce, mining, banking and finance, investments, technology transfer and humanitarian assistance, through the said Extraterritorial Trade Mission Office or its alternative.

It is our belief that such a relationship can lead to economic development and upliftment of the standards of living of our people.

The origins of the Maseko Ngoni Kingdom can be traced in history to the amaNgcamane Maseko Nguni/Ngoni Kingdom which covered present day eSwatini and parts of the Republic of South Africa. In Malawi, the Maseko Ngoni are found in twelve of the country's twenty-eight districts. After migrating from eSwatini and South Africa, the Maseko Ngoni established settlements in Lesotho, Zimbabwe, Tanzania Mozambique and Malawi. Finally, the Maseko Ngoni established a vast Kingdom which sprawled over large parts of Mozambique and Malawi. King Gomani I, was executed by European imperialists for resisting British colonial rule over his Kingdom.

I am a direct descendant of Ngwana Maseko, Prince and heir to the throne of the amaNgcamane Maseko King, who left the Kingdom to establish his own after a quarrel with his royal father. My brief profile, as written by the Maseko Ngoni Heritage Trust, is attached.

Your attention to this invitation, Chief Prime Minister, will be immensely appreciated.
