### Reference: Funding Opportunity

Prime Minister Chief Gees-Due OO-Neh-Gah Usti of the Southern Cherokee Nation and The Red Fire People (State of SCNRFP), and Approved by our Theocracy Government, and the Persons Empowered to Act on Behalf of the State of SCNRFP in actions concerning our Theocracy Government Making Blessings Available, hereby acts as follows:

To Whom It May Concern:

Our government is now offering multiple types of funding opportunities for your benefit, to include but not limited to government funds to multiple entities globally, all levels of government, central government, ministries, domestic local governments, tribal governments, central banks, commercial banks, organizations, private companies and private individuals, and many others in many countries now all enjoying this opportunity, no guarantee needed as before, rather this is being offered as a referral fee. Receivers can use their share for any legal purpose, no project required. We do not need to receive any projects or seek to approve any projects. The receiving bank will determine what amount is acceptable to their bank. If one transaction is not enough more transactions can be made available up until this opportunity is no longer made available by our government.

Our government funds generated by our country's GDP are in Bovillus Reserve Bank. All our government funds have already gone through AML compliance, Basil Accords, have already had background checks, and has proper KYC. However, no information will be released except bank to bank with secure communication.

We have provided you and any brokers you may be working through with an NDA to protect you and your brokers who provide a real and proper source. If you choose to sign an NDA it shall be sent to our government email address: [scnrfp@stategov.services](mailto:scnrfp@stategov.services)

Our banker is standing by ready, willing, and able to connect once all required information is received. A WhatsApp group chat can be formed for introductions only; however, all documents will only be sent via secure communications bank to bank.

Procedure: First you must present a bank or depository or trading that can accept a Ledger-to-Ledger transaction or API to API or Server to Server or .json direct bank to bank, and that has a clearing house either internally or associated with one somewhere in correspondent. Note: none of these transactions we are sending are not being sent via Swift. Once you provide proper complete details above our banker will follow up. Provide Name of Institution, Name of Institution Officer, and Direct Complete Contact Details of Banker to include but not limited to direct banker call number and direct email address. If all is not received as stated above nothing will transpire.

If they have a need for more than the transaction is making available for their referral fee percentage, then they will have to do more transactions to reach the amount they are desiring for their private project or other legal use while collecting their referral fee percentage to add up to what they are looking for.

Beyond their referral fee percentage, if they want our government to do more and put our government money into any private project or other legal use, they will have to form an agreement whereby our government receives a percentage of the project for our investment.

If they are seeking grants, it will be a case-by-case decision by our government, even then a grant will only come from and in conjunction with a successful transaction whereby they have provided a proper bank source that will transact our L2L or API to API successfully. Therefore, in these cases they would receive their referral fee and anything beyond this fee percentage will be decided by our government whether we will provide anything in the form of a grant. Mostly the grants will be for a foreign government that either has or is forming a proper diplomatic relationship with our government, thus nation building on our part, or for a humanitarian or disaster relief effort approved by our government.


Again, simply stated, you will need a proper bank to transact. Please follow the attached procedures. Any of these banks or depositories or trading houses you have will need to be in association with a clearing house. Any of these banks will need to be able to transact ledger to ledger, or IP to IP, Nostro/Vostro without the use of Swift or have a correspondent that can. Any of these will need to be able to do both decentralized and centralized transactions.

We can offer M0 Funds for conversion to M1 if you have a bank or trading willing to clear or monetize.
