



THE REPUBLIC OF TRANSKEI (HOSTING NATION) AND The STATE OF SCNRFP (STATE OF SOUTHERN CHEROKEE NATION AND THE RED FIRE PEOPLE) MUTUAL AGREEMENT

PREAMBLE: Below is an understanding of our continued commitment to our previous and ongoing diplomacy agreements and willingness to become a stronger partner for efforts of your country as stated below, and for Peace, Goodwill, and Friendship:

The Republic of Transkei does officially a-da-do-li-s-di, (recognize) The State of SCNRFP (State of Southern Cherokee Nation and The Red Fire People), a recognized international independent sovereign nation and state (country).

The State of Southern Cherokee Nation and The Red Fire People (State of SCNRFP) does officially a-da-do-li-s-di (recognize) The Republic of Transkei, a recognized international independent sovereign state (country).

The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) does hereby official request the establishment of a The State of SCNRFP (State of Southern Cherokee Nation and The Red Fire People) Extraterritorial Trade Mission Office within The Republic of Transkei (Hosting Nation).

Therefore, The Republic of Transkei “Hosting Nation” officially by proper authority invites The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) to open and operate an Extraterritorial Trade Mission Office (ETMO) within The Republic of Transkei “Hosting Nation”, effective immediately upon signing.

Our Great States also comes together in a good way for Peace, Good Will, and Friendship and The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) hereby officially and formerly offers providing support in technologies, trade and commerce, economic development, social needs, technology transfers, education, medical, housing, agriculture, renewable and alternative energies, shipping, mining, remediation, waste, water, green and brown energies to include oil and gas, infrastructure, domestic jobs, banking, financing, trading, investments, depository, communications, flagging nation, financial center, friendly society, gaming, data embassy, peace keeping, allow the opening of government bank accounts in the hosting nation, artificial intelligence (AI), machine learning, robotic process automation or rpa, edge computing, virtual reality and augmented reality, cybersecurity, blockchain, internet of things (IoT), Diplomatic Status, financial center to include a sovereign private banking system, e-trade, humanitarian needs and methods of funding via through and from within our established Extraterritorial Trade Mission Office (ETMO) within The Republic of Transkei “Hosting Nation” and The Republic of Transkei agrees said operations being connected physically and or virtually from The State of SCNRFP (The State Southern Cherokee Nation and The Red Fire People) jurisdiction of the ETMO, said ETMO can be any known method of exterritorial office to include but not limited to in country, regional, virtually and otherwise known acceptable means, allow a foreign capital of the State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People). The passport of The State of SCNRFP

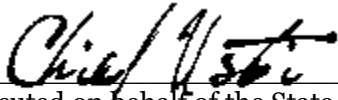

The currency of The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) shall be accepted by The Republic of Transkei, as well The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) will accept the currency of The Republic of Transkei. The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) can be available for use of being a protecting power as a neutral nation. This document is hereby ratified by The State of SCNRFP (The State of Southern Cherokee Nation and The Red Fire People) and The Republic of Transkei.
