RE: PARTNERSHIP BETWEEN THE NATION OF SCNRFP AND THE PITIKO KINGDOM IN SOCIO, ECONOMIC AND INFRASTRUCTURE DEVELOPMENT IN THE AFRAM PLAINS SOUTH IN GHANA

There is no better time than now for your Nation, the State of Southern Cherokee Nation and the Red Fire People, and my Kingdom, the Pitiko Kingdom, to develop a cordial and robust economic and social relationship that will ultimately benefit your Nation and my Kingdom.

The State of Southern Cherokee Nation and the Red Fire People is fully welcomed to execute social, economic and infrastructural development projects ranging from road construction, provision of portable drinking water system, building of educational complexes and institutions, establishment of reliable medical system and construction of ultramodern healthcare facilities, provision of recreational centers, and funding of other potential development projects that my Kingdom needs in the Pitiko, Afram Plains South area.

The rulers of the Pitiko Kingdom are direct descendants of the great and fierce Ashanti warrior, King Tweneboa Kodua. of the Kumawu Royal of the Ashanti Kingdom. It is interesting to note that the Great Ashanti Kingdom begun in Kumawu and the rulers of Pitiko Kingdom are direct descendants of Kumawu.

The Pitiko land is the southern portion of the land fought and captured by King/Barima Asumadu of Kumawu from the Denkyiras in 1700. Due to the bravery of Okoamire (which

name is captured in our Pitiko Kingdom logo), the direct nephew of King/Barima Asumadu, in the Denkyira war, Okoamire was granted freehold ownership of the southern sector of the captured land (now Afram Plains South) from Denkyiras. This land is a peninsula land boarded on the east by the Volta Lake, on the west by Afram Lake, and the north by Obosom Lake.

I, the current King of Pitiko Kingdom, Nana Obeng Boateng II, was installed as the 8th King of the Pitiko Kingdom. I have higher education and currently pursuing a PhD in Accounting even at the age of 82. I am burdened with the socio-economic and basic humanitarian needs of my people.

I, Nana Obeng Boateng II (direct descendant of Okoamire) have full rulership authority on the people of the Pitiko Kingdom, as well as full rulership and ownership authority on the land domain of the Pitiko Kingdom with the Ghana Government, which the government cannot usurp.

Therefore, on behalf of myself, the Elders, and the Kingmakers of the Pitiko Kingdom, do open our Kingdom to the State of the Southern Cherokee Nation and the Red Fire People for the establishment of the ETMO anywhere on this land of the Pitiko Kingdom, and an office anywhere along the banks of the Great Volta Lake.

The Afram Plains South land is a good arable land and indeed a major "food basket" region of Ghana with the potential of growing cash crops for local consumption and exports.

In addition to the above agricultural and livestock potential for the Southern Cherokee Nation and the Red Fire People of the Pitiko Kingdom are reaching out to seek assistance from the State of SCNRFP:

- A. The construction of a Bridge to connect this peninsula land to the mainland of Ghana which will be a landmark achievement on a global scale.
- B. Green Energy such as installation of solar energy for electricity and power.
- C. Provision of portable drinking water and irrigation for agriculture.
- D. Road infrastructure to open up the entire region.

I would like to stress the total consent from all the people and tribes have been received including the elected MP of the land, Hon. Appiah Boateng, who has also attached a letter as well, for the establishment of ETMO office in the Pitiko Kingdom. Additionally, the MP's letter constitutes government sign off and a welcoming approval for the establishment of ETMO office and other developmental and infrastructural projects that will be executed by the State of SCNRFP in the Afram Plains South region of Ghana.

As the King of the Pitiko Kingdom in the Afram Plains South area, I am in the full capacity to provide the State of SCNRFP with optimum legal support pertaining to the use of our natural resources and raw materials in the execution of their infrastructural, development projects and other potential projects to better serve the people of Pitiko Kingdom in the Afram Plains South Area.

I am extremely overjoyed noting that this potential partnership with the State of Southern Cherokee and the Red Fire People has come about through my favorite nephew and Chairman of Mincor Resources Limited. Coincidentally, the mother of his first child out of his loins is of Cherokee heritage from the Hyatt family.

It appears to me that this partnership between the Pitiko Kingdom and State of the Southern Cherokee Nation and the Red Fire People is meant to be.

I, wholeheartedly invite you to Ghana.

Prayers, blessings and protection to you and your family, your people and your Nation.
