Objet: The invite of Southern Cherokee Nation and The Red Fire People's Extraterritorial Trade Mission Office by the Nation of Central African Republic.

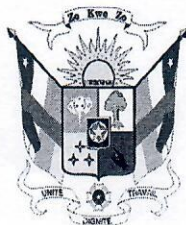

The currency of the Southern Cherokee Nation and The Red Fire People, state of SCNRFP, shall be accept by the Central African Republic as well the Southern Cherokee Nation and The Red Fire People, state of SCNRFP will accept currency of the Central African Republic. This document shall be ratified.
