## State of SCNRFP ETMO Policy Summary

### The State of SCNRFP Government

Our foreign policy summary is simple and straight forward, we become involved in supporting peace and good will, economic development, trade and commerce, social needs and providing technology transfers, however we do not get involved in other business of a hosting nation, we do not get involved in any of their political affairs, for we are a neutral nation and state and we do not push to change anyone into our belief system or any other system, for it is not our mission. Our office will not be handling passports or visas for those coming into the hosting nation, thus this is then also not a concern of the hosting nation. We do handle our own passports within our own nation and state.

Again, our mission is not political, it is an extraterritorial trade mission, therefore our official emissaries are trade representatives and an official extension of our ministry of foreign affairs, ministry of protocol and our nation. Our emissaries are responsible to introduce our nation to the hosting nation, begin the relationship with the hosting nation and maintain it. They are who meet with the hosting nations ministers to discuss the needs and priorities of the hosting nation and responsible to pass this information along to our nation's ministers, in most cases is the minister of finance and friendly society. The People of the Heart Society (POHS – POH Society) is a friendly society and is a State of SCNRFP state-owned financial institution.

Our nation supports nations globally and hundreds of millions of citizens under the NNIA Treaty (International Intergovernmental Organization) and growing. Our nation and our

nation's POH Society supports funding and technologies to nations globally, by which supports jobs, economic development that supports social needs and the economy in a good way.

The support we offer is based on our treasury, our POHS's available services, and the hosting nation's ability to meet the requirements which begins with forming a relationship with the State of SCNRFP. For they do not go to the IMF and not be a member of the IMF, they do not go to other nations without having a relationship with other nations. The State of SCNRFP is backed by the full faith of the government to include gold backing and services that are supported with large available funds.

Our POH Society will look at any above ground or below ground asset to provide funding. We offer trading and monetizing as provide funding whereby the hosting nation does not have to grow their debt and rather reduce their debt, however, we also still provide loans as well.

The extraterritorial trade mission office is a support office whereby our nation's emissaries meet with the hosting nation regarding their needs, discussing how they desire to move forward, gets involved in the planning and oversees the inspection of each phase of any project to completion and reports projects progress to our nations minister of finance, who reports to the POHS.

Our emissaries seek to find out the hosting nations financial needs, whereby we offer trading, monetizing, loans, investments. Our emissaries seek to find out the hosting nations needs of economic development, social needs, technologies and otherwise.

We look to provide funding to these hosting nations, even to the nations that are under moratorium by the IMF.

We offer some services much like the ISB, providing POHS accounts to those that do not have their own friendly society, banking, or central bank, so they can benefit in the same way as owning their own central bank and servicing their own citizens.

We support trading and monetizing of in ground and below ground assets that are properly valued and bankable, and or those that have been properly engineered and bankable.

We support funding to member nations of the UN who have proper relationship or are willing to have a proper relationship with our nation, and we support tribal nations who are willing to have a proper relationship with the NNIA and our nation.

We look to provide low interest loans to allow nations the ability to pay back and create proper profit centers, while retaining their assets so as not to be weakened the hosting nation, but rather grow the hosting nation domestically and international, but with the most focus on their domestic needs for medical, education and training, jobs, agriculture,

housing, economic development that supports social needs, trade and commerce, technologies and technology transfers through our extraterritorial trade mission offices and with the support of emissaries and our ministries.

Most nations are accustomed to how the IMF works, that they must be a member of the IMF and meet the requirements of the IMF. With our POH Society one must establish a proper relationship with our nation and the POHS respectfully.

Many of these nations today are under moratorium by the IMF and are sending government officials around the world to meet with anyone now locate funds. Many are turning to nations that take advantage of the situation and create unfair trade practices. However, they could come here to meet our nation for funding and received fair trade practices, with creative ways to obtain the funds without increasing their debt, but if they do desire a loan, we would provide the best interest possible and provide creative methods that the nation can generate profit centers to offset the debit and interest.

Our emissaries are continuing to meet with the hosting nation on an ongoing basis, but if the hosting nation desires to meet with our nation and the POH Society here in our nation we welcome the hosting nation in a good way.

In the same way they go and meet with other nations and financial institutions globally to obtain funds, it is respectful for them to come here and meet with our nation and the POHS, if they desire our funds as well.

When there is a reason, our ministers will travel to the hosting nation, which ministers who will travel to the hosting nation will depend on the hosting nation's needs and reasons for meeting. There will be follow up also by our minister of finance and by the POHS president.

All other ministers such as minister of technologies, minister of mining, minister of energy, (oil, gas, geology), minister of health, minister of economic development, minister of agriculture, minister of housing, minister of education and training, minister of economic development, minister of social needs, minister of public relations and other ministries are delighted to meet here in our nation with the ministers of the hosting nation at any time. Once there is an established relationship between the hosting nation and our nation, our ministers will be delighted to meet in the hosting nation to support reasons and needs of a hosting nation ministry. However, mostly it will be our emissary trade representatives that will be on the front line and first to respond. Our ministers become more involved in assisting planning for the hosting nation ministry once a need or desire has been presented by the hosting nation to the emissary trade representative.

The extraterritorial trade mission office (ETMO) and the official emissaries are there for the benefit of the hosting nation and to lessen their travels and cost to come and visit here just to acquire funds, and to support them directly with our trade services, such as technologies

and technology transfers and to assist them in holistic planning, introducing our training and job programs through our internationally accredited technical training schools and our colleges via virtual class rooms, introducing building materials that can be produced domestically that saves on import cost and does not destroy their own environment or deplete their own natural resources, and many more trade services.

The mission office is not an embassy or a consulate office but must be extraterritorial due to the fact we are a nation and not an individual or a company. Our extraterritorial trade mission office is a cost of our nation, but it there to benefit the hosting nation.

To get started the hosting nation needs to meet with our official emissaries and complete the 8.a. document being provided by our nation via or official emissaries. For it is the emissary's position to also present the official documents of the State of SCNRFP to the hosting nation as, they are an extension of the State of SCNRFP ministry of foreign affairs, ministry of protocol and our nation. Otherwise, you are welcome to send an official representative of your nation to our nation to get started followed by completing the 8.a. document.

The extraterritorial trade mission office has the purpose of a trade mission, and not any purpose of a position of military since the State of SCNRFP is truly a neutral nation.


We welcome the hosting nation is a good way to the benefit of the hosting nation.
