Furthermore this document has the same force and legal validity even if it is not done on official letterhead of the Republic of El Salvador and for that reason is why the lawyer give public faith that the document and the signature are real and legitimate.

Moreover the Republic of El Salvador is welcoming you Prime Minister of the State SCNRFP Gees-Due OO-Neh-Gah Usti for having a formal meeting to discuss further details about the opening of an ETMO in their country. They has given a tentative interval of time to hold a meeting on the week of June 10, 2019 and they're in need of your attendance confirmation as soon as possible.



Finally I want to express my sincere thanks for the given support and highlight the hard work behind this huge achievement in the Republic of El Salvador. Since day one I have served with goodwill and clarity for The Southern Cherokee Nation and The Red Fire People and we (me and my son) are proud to work and keep working with the same determination and discipline, there's many open upcoming possibilities in the region that are under our work scope agenda and are also in need to be supported in order to be completed.

El Salvador.**




Therefore, the country of the Republic of El Salvador officially by proper authority invites the Southern Cherokee Nation and The Red Fire People to open and operate an Extraterritorial Trade Mission Office within the country of the Republic of El Salvador.




