Professional License (A) for Medical and Wellness and Therapies and Counselors and Legal: If you hold a professional license (A) within the State of SCNRFP, now is the time to make sure you complete your annual registration. **The deadline to complete your**

annual registration for corporations filed in 2022 is on April 01, 2023, and no later than April 15, 2022, for any existing corporations registered prior 2022.

Annual registration begins each calendar year on Jan. 1 and goes through April 01. It's important to complete your registration each year, not only to be legally compliant, but also to ensure the state has your current mailing address, filing name and management structure.

Fees

Along with filing your annual registration, a fee must be paid to complete the process. Fees differ based on the type of business you are doing in State of SCNRFP:

- Professional License New 1,500.00
- Professional License Annual 350.00
- However, if your current stated fees differ from the ones listed above, then you may owe for previous years or for overdue late fees. Be sure to check the amount owed before you submit your payment.

The State of SCNRFP accepts the following forms of payment:

- Check
- Certified Bank Check
- Money Order

Checks that are returned are subject to an additional 30.00 fee. If you fail to make your payments, you might be subject to a civil suit, or your entity might be administratively dissolved or revoked by the State of SCNRFP Board of Professional License.

- (a) All licenses shall expire annually unless renewed. All applications for renewal
 of a license shall be filed with the board prior to the expiration date, accompanied
 by the annual renewal fee prescribed by the board. A license which has expired
 for failure of the holder to renew may only be restored after application and
 payment of the prescribed restoration fee within the time period established by
 the board and provided the applicant meets such requirements as the board may
 establish by rule. Any license which has not been restored within such period
 following its expiration may not be renewed, restored, or reissued thereafter. The
 holder of such a canceled license may apply for and obtain a valid license only
 upon compliance with all relevant requirements for issuance of a new license.
- (b) As a condition of license renewal, the board shall require licensees to provide proof, in a form approved by the board, of a minimum of five hours of continuing education courses as approved by the board in the area of cosmetic laser services, equipment safety and operation, procedures, and relative skin

modalities, directly taught by a licensed physician or certified continuing medical education or continuing education educator.

2022 State of SCNRFP Annual Registration of Corporation

If you own a corporation in the State of SCNRFP, now is the time to make sure you complete your annual registration. The deadline to complete your annual registration for corporations filed in 2022 is on April 01, 2023, and no later than April 15, 2022, for any existing corporations registered prior 2022.

Annual registration begins each calendar year on Jan. 1 and goes through April 01. It's important to complete your registration each year, not only to be legally compliant, but also to ensure the state has your current mailing address, filing name and management structure.

Fees

Along with filing your annual registration, a fee must be paid to complete the process. Fees differ based on the type of business you are doing in State of SCNRFP:

- Corporations New 300.00
- Corporations Annual 150.00
- However, if your current stated fees differ from the ones listed above, then you may owe for previous years or for overdue late fees. Be sure to check the amount owed before you submit your payment.

The State of SCNRFP accepts the following forms of payment:

- Check
- Certified Bank Check
- Money Order

A corporation that is within the State of SCNRFP foreign territories under diplomacy agreement is within a Zero Tax State, however, tax savings service fees do apply.

• Next Steps

- Provided all of your information is valid and your name has not been taken, you will receive your Certificate of Incorporation within the specified processing time.
- Within 90 days of incorporation, each State of SCNRFP corporation must file an initial annual registration that lists three principal officers with the Secretary of State. The fee for initial filing is 300.00
- Corporations that form between October 02 and December 31 must file the initial annual registration between January 01 and April 01 of the next calendar year.
- Each year, you must file an annual registration for your corporation between January 01 and April 01. If you do not, your corporation will be administratively dissolved for failure to file your annual registration.
- You may file an annual registration for a period up to and including 3 calendar years in advance.
- Any corporation that already exists and was registered prior January 01, 2022, shall pay an annual fee for the year of 2022 of 150.00 annual registration fees and shall pay annual fee for each year to come, and on the schedule as listed above. This fee for existing registered corporation prior January 01, 2022, shall be due no later than April 15[,] 2022, Effective Immediately. If annual registration fees for 2022 are not received, your corporation will be administratively dissolved for failure to file your annual registration.
- Any changes on your annual report shall be reported and provided via email to <u>scnrfp@stategov.services</u> and payment shall be mailed to the State of SCNRFP
- It is important to note that registering with the State of SCNRFP is not the only step you will need to take before you can start doing business in the State of SCNRFP. You will need to check to see if a professional license is required, business license, dual general citizenship, and otherwise.

Your National ID Card can be renewed up to 150 days before the expiration date of your National ID Card. Allow up to 30 days for your permanent ID Card to be delivered. Your renewed National ID Card will be valid for up to 4 years. Provided from the State of SCNRFP Foreign and Domestic Jurisdictions.

- New Dual General Member Citizenship (CC-7) 100.00 for Enrollment, No Renewal Fees, New National ID Card 45.00 and Renewal National Card 35.00 and Lost National ID Card Replacement 35.00
- New Lineage Member Citizenship (CC-7) NO CHARGE For Enrollment, No Renewal Fees, New National ID Card 35.00 and Renewal National ID Card 35.00, and Lost National ID Card Replacement 35.00
- However, if your current stated fees differ from the ones listed above, then you may owe for previous years or for overdue late fees. Be sure to check the amount owed before you submit your payment.
