To Whom It May Concern,

Our theocracy is based on our way of life. Whereas, our mission is peace, good will, humanitarian, spiritual and human growth, and shall not pose nor support any kind of threat to life and liberty.

Theocracy, **government by divine guidance or by officials who are regarded as divinely guided**. In many theocracies, government leaders are members of the Priesthood, one or more priests rule in the name of a deity, and the state's legal system is based on religious law.

Whereas: we are the Ancient Order of the Priesthood; We are the Keepers of the Sacred Fire, the Red Fire, the Eldest Fire, and the Predominant Fire; We are known as the People of the Heart.

Whereas: Southern Cherokee Nation and The Red Fire People, State of SCNRFP **Member Citizen** has under oath agreed to follow the Ancient Axe of Authority, the Ancient Order of the Priesthood, and the Southern Cherokee Nation and The Red Fire People, State of SCNRFP Law, policies, procedures and protocols. The Southern Cherokee Nation and The Red Fire People, The State of SCNRFP (Tsigamogi, Chicomogie, Chickamauga, and Lower Cherokee) an International Independent Recognized Sovereign Neutral Nation and State, Under the Ancient Axe of Authority and the Ancient Order of the Priesthood, as a Theocracy Government.

Whereas: the theocracy government is located within the traditional sovereign boundaries and within the recognized foreign sovereign boundaries and recognized sovereign offshore territories, as a recognized sovereign government. Theocracy government functions are carried out within both the Traditional and State government offshore locations.

Whereas: all rights remain, to include but limited to Divine law, customary law, inherent law, natural law, hereditary law, first statute law, international law, statute, court decisions, moral, cultural, traditional, religious, human rights, religious freedom, constitutional, acts of congress, bill of rights, articles of confederation, the American Indian religious freedom act, UN religious freedom (Art. 18 (1): "**Everyone shall have the right to freedom of thought, conscience and religion. This right shall include freedom** [...] either individually or in community with others and in public or private, to manifest his religion or belief in worship, observance, practice and teaching."), Title VII of the Civil Rights Act, AAAP-1, SCNRFP Court & Laws, Ancient Axe of Authority, self-determination, non-intercourse, UNDRIP, reserved rights doctrine, State of SCNRFP laws, and otherwise, whereby sovereign jurisdiction remains.

Whereas: our way of life, our belief system, our teachings, our form of worship, and divine law of our Deity does not believe in any of our member citizens subjecting themselves by force or by will to any element that violates any of our way of life and the divine law, and that would pose and or support any kind of threat to life and liberty as these vaccines have indicated to have done. These vaccines have used elements, to include but not limited to fetal cells at one stage or another were used in the process of the development of these vaccines and in some cases are still present in some of the vaccines, either are a violation

of our way of life, our belief system, our teachings, our form of worship, and divine law of our Deity whereby a threat to life and liberty still exists, and the use of any of these vaccines as such pose and or support a threat to life and liberty.

Whereas: Religion is the entire collection of beliefs, values, and practices that a group holds to be the true and sacred. Vaccine Exemptions via Religious and or Medical your Legal Right. Therefore, all of those under the Ancient Axe of Authority, the Ancient Order of the Priesthood are legally exempt under religious status due to our sincerely held religious beliefs. All those with Medical Exemption shall request a letter of medical exemption from one of the many Southern Cherokee Nation and The Red Fire People, State of SCNRFP doctors or from any properly licensed doctor globally.

Whereas: our way of life and rights extends globally to each and every member citizen of the theocracy, wherever any member citizens of the theocracy is geographically located, as is the case with any religion being granted the same. Therefore, The Southern Cherokee Nation and The Red Fire People, State of SCNRFP acknowledges the forementioned as being **Religious Exempt**.

Whereas: The Southern Cherokee Nation and The Red Fire People, The State of SCNRFP accepts and acknowledges the doctor's medical findings, determination and records as presented to the State of SCNRFP of the said patient as being **Medically Exempt** based on quote: "the patient having pre-existing medical conditions which would be exacerbated with these forms of said vaccinations or injections by which has been presented."

Whereas: Additionally, quote: "it has been determined by the patient's doctor that the particles in the said vaccinations or injections will cause harm or a severe auto-immune response with the patient and will in all probability cause severe health challenges and reactions if taken."

Whereas: it should be noted and observed that the patient's file and all medical records to substantiate the patient's clinical condition(s) reside with the doctor's office and can only be released by the patient's authorization for the strictest of confidence under HIPPA law and AAAP-1. Therefore, any medical records will have to be requested and obtained from the patient's medical doctor directly due to HIPPA law and AAAP-1 law.
