Prime Minister Chief Gees-Due OO-Neh-Gah Usti of the Southern Cherokee Nation and The Red Fire People (State of SCNRFP), and Approved by our Theocracy Government, and the Persons Empowered to Act on Behalf of the State of SCNRFP in actions concerning the international diplomatic accords together, hereby acts as follows:

It is my honor to communicate with your esteemed self and beautiful historical country. I hope this finds you well and wish you a long life and blessings. Your knowledge and actions of your esteemed career of public service, education, and business speaks for itself as being a great benefit to your nation.

Officially, The State of SCNRFP would like to thank you in advance for the time that you are so kindly providing The State of SCNRFP for the benefit of your nation, our nation, and for the world.

State of SCNRFP does not agree with, nor support, nor participate in with colonization, rather we believe in peaceful, fair and equal self-determination and sovereignty. We support preserving traditional institutions, customs, and values. We support individual freedom, limited government, rule of law, peace through moral strength, fiscal responsibility, equal free markets, and human dignity. We believe in hope, prosperity, safety, and peace, no matter of race, color, spirituality, or creed, we are one human race. We do not support neocolonialism, cultural imperialism, nor exploitation, we believe in moral leadership.

The State of SCNRFP as a neutral unaligned State poses no kind of threat to life, liberty, economic, and social. We believe in respecting both our culture and traditions and those of others. As a theocracy, we are a government by the Creator.

The State of SCNRFP is in keeping with Diplomatic Decorum, Protocol, and Etiquette.

Diplomacy is the art and practice of building and maintaining relationships and conducting negotiations with people using tact and mutual respect.

We look to offer partnerships to countries who are seeking and requesting any funding, investments, technologies, foreign aid, disaster relief, foreign and domestic sovereign wealth funds, trading, financial enhancement methods, increased currency value creation and trade, or otherwise, thus streamlining the global mission forward, and in keeping with the national interest of the State of SCNRFP. We offer Humanitarian as a Gift of Offerings. Offerings, on the other hand, are voluntary gifts expressing gratitude or support for specific needs, given freely, which are treated differently from that of non-humanitarian acts such as funding, investments, technologies, foreign aid, and otherwise non-humanitarian acts. There are two types of investments, either from our government with said interest or from a company incorporated within our government with said interest. Funding and investments are made financially available in multiple transactional ways, to include but not limited to on and off ledger funds being cleared via hosting nation central bank and a central bank government account established for our government to deposit dedicated funds. Funding/loans, Investments, and Humanitarian are all separate opportunities and handled differently.

Separately, we have received many requests from tribes within these countries, their request is handled differently, they are handled via NNIA supported by the State of SCNRFP <a href="https://statescnrfpgov.ag/nnia-convention-page">https://statescnrfpgov.ag/nnia-convention-page</a>

Further, it opens the ability for countries, their ministries and agencies to come directly to our country to partner, and The State of SCNRFP Emissaries to go to any ministry or agency in any countries and inform them of these positive missions forward in a partnership with our Theocracy Government.

# We desire to have a good and long official relationship between our nations for peace, good-will, and friendship.

The State of SCNRFP missions is that of peace, good-will, and friendship providing ways to support and benefit the hosting nation and your people with humanitarian, investments, funding, foreign aid, technologies, economic development, social needs, disaster relief, and otherwise related under a commercial and economic diplomacy agreement. We offer to come together under a long-term diplomacy agreement 8a between the countries, followed by an offering of an 8b territorial agreement to be discussed sometime in the future which will additionally benefit the hosting nation.

The State of SCNRFP provides three defined principal ways that would be most proper and good for our two great nations to work together, feel free to choose all three. It should be aware that Number One is necessary to have a proper relationship. Number Two is optional but provides even more benefits to the Hosting Nation. Number Three is possible with or without Number Two and even possible without Number One, but we do desire to have a good relationship with the Hosting Nation and see the Hosting Nation benefit ongoing.

Please find attached herewith a letter marked 8.a. for intimating you with formal request of the establishment of an Extraterritoriality Trade Mission Office (ETMO) and for your acknowledgment, recognition, and approval of the 8.a. document.

The 8.b. provides a number of more benefits in support to your state to include ongoing investments and funding long-term. It should be noted that we are providing and introducing one hundred percent investment into economic centers whereby we are also providing equal sharing of The State of SCNRFP receivables for humanitarian, social needs, and to establish economic centers to the benefit of your country which is far better than any economic zone known today. This sharing will additionally assist in supporting any needs you may have a desire to support within your own country. Making available many kind and generous worthwhile valuable offers and opportunities that provides important methods of financial support and profits centers with having the best interest of your great state. These profits centers can be better than unpredictable foreign aid, rather may provide 365 days a year of long-term foreign aid through proper relationship and cooperation.

Equally our government is most interested and willing to make a purchase or long-term lease (purchase preferred) on one of the islands, to be used for a humanitarian base and disaster relief, providing ongoing support and benefit to the hosting country with humanitarian, and opportunities of investments, funding, and value technologies. It should be noted that many of these islands and shoreline properties are being taken over by the ocean as we speak and will one day soon be underwater caused by the rise of water globally. At such a time it will not have the same usable value any longer to the country. Much is changing globally with the shifting of world powers and global currencies, to include the world's reserve currency. Many more needs are coming caused by economic changes, climate changes, war, disasters, and otherwise. The State of SCNRFP poses no threat as we are an unaligned and neutral nation. The State of SCNRFP has many valuable technologies to assist with many current and forthcoming troubles. Without making mention of all the many current and forthcoming concerns it is good to have more positive relationships for any additional contributions to see you through.

Through these means of our request, we seek first to develop a relationship of Peace and Goodwill and Friendship, followed by the strengthening of both States and our peoples through making available to your great state with support of humanitarian, social needs, economic development, technologies,

investments, funding and other opportunities in a good way, as you may need, desire, and suggest, while making available many kind and generous worthwhile offers and methodologies providing important methods of financial support and profits centers with always the best interest of your great state.

Pandemics has also shown how easy things can happen in creating many needs by countries globally, therefore, no better time for our relationship to begin in ways to be ahead of the curve and the needs its presents, no better time to begin a friendly relationship together whereby we desire the best for your nation and ours. There could be no better time for our great states to form a friendly relationship and come together in a good way for first peace and goodwill and friendship, whereby we desire the best for your nation and people and ours. The State of SCNRFP believes that such a relationship will be long-lasting and mutually beneficial to both our great states.

#### SEPERATION OF GOVERNMENTAL POWERS EXPLAINED:

The State of SCNRFP and Its Citizens Observes Our Government's Separation of Governmental Powers, Designated Capitals, and Functions of both The Central Government and The Tribal Government: to include but not limited to the Defined Boundaries, Foreign and Domestic Jurisdictions, Diplomatic Offices, Extraterritorial Trade Mission Offices (ETMO), International Foreign Territories, under International Diplomacy Agreements and Treaties with the Foreign Hosting Countries and Governments. These Sovereign Jurisdictions respect International Law and are under the Laws and Rights of The State of SCNRFP Central Government and Tribal SCNRFP Government, and both being a Separation of Governmental Powers, with both being under the Ruling Power of The Supreme Authority of The Theocracy Government who is Divinely Guided by The Sovereign Authority of The Great Spirit Creator.

Basically, it is their government choice, funding, or investment, or for humanitarian reasons they must have relationship, or we will provide them with large capital if they have a clearing house at their central bank to take in off ledger to on ledger funds. If they can do off ledger to on ledger, we not only share nicely with their government but also, we will take some of ours and provide to their humanitarian for displaced people project, and make investments into their country

The State of SCNRFP Central Government operates within the foreign territorial jurisdictions located globally under foreign international diplomatic agreements and foreign diplomatic offices located globally. The State of SCNRFP is properly recognized as a country by a number of member states of the United Nations globally.

Within the Central Government of the State of SCNRFP is the Traditional Tribal Government SCNRFP which operates within the Recognized Sovereign Jurisdictions and Sovereign Treaty Boundaries located in the beautiful Mountains of the Blue Ridge, Appalachian, and Great Smoky Mountains as the original possessors of the land and with written treaties with Spain, France, England, and USA. The domestic tribal government only operates within the domestic boundaries and does not conduct any foreign state affairs. The tribal government has no need to operate beyond its boundaries and only conducts Internal Tribal Affairs. The State of SCNRFP Central Government operates Internationally in Foreign State Affairs and supports both the State government and the Tribal government. Thus, any tribal government affairs have remained domestic capital and towns within our traditional treaty boundaries and original homeland. While any State Affairs with regard to The State of SCNRFP is located geographically within

the State of SCNRFP recognized foreign jurisdictions of The State of SCNRFP foreign territories and foreign diplomatic offices, thus an internationally independent recognized sovereign neutral nation and state (country) under The State of SCNRFP laws and international laws with a non-codified constitution. The traditional tribal government remains with rights and laws as a tribe.

Both The State of SCNRFP, a recognized international independent sovereign neutral State and the tribal government are both under the Theocracy Government.

The State of SCNRFP has citizens, and dual citizens residing in countries globally like any other country, and tribal members are also citizens of The State of SCNRFP Central Government like any other country. The Tribe has only tribal lineage traditional citizens and those who has been adopted.

**The Tribe:** (Tsigamogi, Chicomogie, Chickamauga Cherokee, and Lower Cherokee):

- •Tsigamogi has always been an independent sovereign and remains so today
- Chicomogie, Chickamauga Lower Cherokee has always been sovereign and became independent of that of the Overhill/Upper Cherokee Nation in the 1700's and again confirmed by letters between the Overhill/Upper Cherokee and U.S. President Thomas Jefferson in 1809 sharing the sovereign defined boundaries.
- 1832 U.S. Supreme Court rendered a decision that we are an independent sovereign by majority decision.

- The Tribe's Enclave in America is Under Our Sovereign Treaty Boundary
- The Tribe is under the Theocracy Government and follows the visions and prophecies of the Creator.
