Subject : Offer C3C-SENEGAL Group financing.

His Excellency Mr Ambassador

I acknowledge receipt of your reference letter relating to an offer to finance the C3C-SENEGAL Group which has expressed an interest in supporting the government of Burkina Faso for the implantation of its development projects and programs through the mobilization of funds from a consortium made up of several technical and financial partners. Moreover, the Group wished to establish a diplomatic and economic relationship between Burkina Faso and the Southern Cherokee Nation and The Red Fire People (SCNRFP).

Hereby I would like to send them my gratitude for the interest in the socio-economic development of Burkina Faso.

However, regarding the funding offer, the documents received do not allow us to assess the conditions and methods of mobilizing the proposed resources.

As for the desire to establish a local economic office for relations of economic and diplomatic cooperation between the SCNRFP and Burkina Faso, in view of the absence of cooperation agreements between the SCNRFP and our country, I suggest beforehand that this issue be dealt with to facilitate further discussions with the government for the funding of public projects.

However, this prerequisite does not apply to relations between private companies in the two nations, as long as it complies with the procedures and rules in effect on the matter.

Please accept Excellence Mr. The Ambassador the expression of my perfect consideration.
