- **Tests held outdoors on grass and fully fenced, with a run-out of at least 50 yards. Lure is a continuous loop. Electronic timer with manual back-up.**
- **Two trials per day, run concurrently. unlimited tests per trial.**
- **Trial hours: Check-in begins at 8AM; all dogs must be checked in and in line, ready to run by 3PM. We do not schedule run times. Arrive by 2:30 pm any dogs not checked in, in line ,and ready to run by 3PM may forfeit entries.**
- **For all fees collected on site: Cash or credit card only; no checks accepted.**

## PARKING

All Exhibitors, Participants, and Spectators must enter Fairgrounds using the main entrance at 1250 E. Gum Ave..Parking attendants will direct each vehicle to the FAST CAT parking location. NO VEHICLE is allowed to drive on or about the show grounds until after best in show. PARKING FEE \$10.00 PER DAY. Parking opens at 6 am, movement is prohibited after 7 am , once unloaded all vehicles must report to parking lots . no exceptions

## Awards:

- Light blue ribbon awarded for each qualifying run.
- New title rosettes for BCAT, DCAT, and FCAT will also be awarded.
- All awards must be picked up at the event; no awards will be mailed.

## Eligible dogs:

For all dogs at least 12 months of age, and individually registered with the AKC. This includes all AKC registered purebreds, Foundation Stock Service (FSS), Purebred alternative Listing (PAL), and AKC Canine Partners. Spayed or neutered dogs and/or dogs with breed disqualifications may enter.

- Per AKC Section 3.2: No bitches in season may run. (See **Inspection** below)
- All dogs must run on a limited slip or flat collar, harness, or naked.
- NO choke, pinch, or electronic collars allowed.
- Tags to be removed or taped flat to the collar.
- Each dog may run only one time per test (defined by event number).
- Dogs must be inspected before each run.

### **Penalties:**

A penalty of \$10 will be assessed for any loose dog not competing with the test in progress, or for dogs causing excessive delay to retrieve from the test field. Dogs and/or handlers responsible for more than one offense will pay double fines and may be prohibited from competing further in the remaining events. In that event, NO refunds will be offered for dogs/handlers disqualified from further participation.

### **Inspection:**

FastCAT is an athletic activity that will test and tax a dog's physical strength. Please realize that dogs that are overweight and/or not in condition may be at greater risk for injury.

- Prior to each run, each dog will be inspected for lameness, fitness to compete, and whether bitches are in season.
- If a dog fails initial inspection (lameness, unfit, in season), applicable entry fees will be refunded, less \$5.00 per entry fee for processing.
- If a dog is cleared for competition by the committee and later is excused, injured, or disqualified, no refunds will be issued.

### **New to FastCAT? Or just need a few reminders? Read on!**

- Plan for a fun, safe day!
- 
- 
- Please plan to bring your own portable shade, chairs, crates, and water; parking is near the test area, Lavatories are a short walk away plan for a variety of conditions, including wind.
- The test area is well away from the dog show, but for the safety of your dog/s and other participants, your dog should have a reliable recall.
- Please listen to the directions given by our experienced Lead Inspectors as they are responsible for ensuring compliance with AKC regulations in the field.
- Bring two sturdy leashes (no show leads or retractable leads) for your dog: one to hold your dog and one to catch your dog. Please arrange for someone to either release or catch your dog, since you cannot be in two different places 100 yards apart. Be sure your dog can be caught at the end of the course (which is enclosed, of course, but is temporary fencing).

- Exhibitors should be familiar with all FastCAT rules prior to participating. This AKC publication provides all the information you will need: <https://images.akc.org/pdf/rulebooks/AKC1812-REFCAT.pdf>. A copy will also be available at the check-in table.
- Toys and treats may be in the catch area out of sight of the dog until after the dog crosses the timing line.

### **Withdrawal of entries:**

- No entry fees may be refunded if the test cannot be held or completed for any reason beyond the control of the host club.
- No entry fee will be refunded if a dog is absent, disqualified, excused, or banned by action of the Field Test Committee, except for dogs not passing initial inspection as provided for in this premium list.
- Any entries pulled in writing prior to February 18, 2026 (mail/email) will be refunded, less the \$5 processing fee. If an entered bitch comes in season, a written request for withdrawal with veterinary documentation will be honored on the day of the entered test. Another dog may be substituted for a bitch in season.

### **What exactly is FastCAT?**

If you've read this far, you probably know, but ...

- FastCAT is a timed, straight 100-yard dash for dogs.
- Dogs chase a lure to the finish line where there is a catch pen.
- They earn points based on the time taken to get to the end, adjusted for the size of the dog (height at the withers).
- AKC titles are earned at specific point levels and appears after the dog's name:
  - BCAT = 150 points
  - DCAT = 500 points
  - FCAT = 1,000 points – and it goes up from there!

**AGREEMENT**

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
