1. Who We Are

Featherlight Capital Limited (“we”, “us”, “our”) is a private equity investment manager. Our registered office is Suite 1, 7th floor, 50 Broadway, London SW1H 0DB, United Kingdom. This notice explains how we collect and use personal data through this website (<https://featherlight.capital/>) in accordance with UK GDPR and other applicable data protection laws (including, where applicable, the EU GDPR).

2. Information We Collect

We may collect and process the following personal data when you interact with our website:

Contact Form & Email:

- Name
- Email address
- Any message or information you choose to provide

Automatically Collected Data:

- IP address
- Browser type and version
- Operating system
- Pages visited and time spent
- Device and connection information

This may occur via cookies or similar technologies

3. How We Use Your Personal Data

We use personal data for the following purposes:

- Responding to enquiries submitted via the contact form.
- Communicating with you about our services.
- Analysing website use to improve functionality.
- Meeting legal or regulatory obligations.

We do **not** sell personal data.

4. Legal Basis for Processing

Under UK GDPR and other applicable data protection laws, we rely on the following lawful bases:

- **Legitimate interests:** e.g., analysing website traffic, responding to enquiries, and improving our website.
- **Consent:** where you explicitly provide it (e.g., cookies that are not strictly necessary).
- **Legal obligation:** where required by law.

5. Cookies and Similar Technologies

What Are Cookies?

Cookies are small text files placed on your device to collect standard internet log information and visitor behaviour data.

How We Use Cookies:

- **Strictly Necessary Cookies:** Essential for basic site functionality.
- **Performance/Analytics Cookies:** Help us understand site use.
- **Functional Cookies:** Remember your preferences.
- **Marketing Cookies:** (if applicable) track visitor behaviour for advertising.

Consent for Cookies:

Non-essential cookies are placed only with your consent. You can accept or decline via the cookie banner.

Managing Cookies:

You can manage or disable cookies through your browser settings. Instructions are available in most browser help sections.

6. Third-Party Analytics

We may use third-party services (e.g., analytics providers) to understand site performance. Those providers may set their own cookies.

We require that such third parties provide appropriate safeguards under UK GDPR.

7. Data Sharing

We may share data with:

- Service providers who help operate this website.
- Law enforcement or regulators where required by law.

We do not share personal data for advertising or sale to third parties.

8. International Transfers

Your information may be transferred outside the United Kingdom for processing by our service providers. Where personal data is transferred outside the United Kingdom or the European Economic Area, we rely on appropriate legal safeguards, including adequacy decisions or approved contractual protections such as Standard Contractual Clauses, to ensure personal data remains protected.

9. Data Retention

We retain personal data:

- For as long as necessary to respond to your enquiry and typically no longer than 12–24 months unless further correspondence or legal obligations require longer retention;

- As required by legal, tax or regulatory obligations.

10. Your Rights

Under UK GDPR, you may have the right to:

- Access your personal data
- Correct inaccurate data
- Request deletion (in limited cases)
- Object to processing
- Withdraw consent

We take reasonable technical and organisational steps to protect personal data against unauthorised access, disclosure, alteration or misuse, consistent with our internal policies.
