The hours of market operation are from 11am-5pm. You must be in your spot and be ready at 11 AM. Vendors must keep their displays up until the market ends at 5pm. The event ends at 9 PM and all vendors are welcome to stay until the grounds close at 10pm.

- **Producers that sell goods should be selling goods created by the Producer. No wholesale products allowed unless approved by Growing South Milwaukee.**
- **All Vendors must provide proper permits to sell (for artists/makers, a Seller's Permit is required).**
- **Products sold should match Vendor application.**
