You MUST READ & INITIAL each line of the Terms & Conditions to participate.

The hours of market operation are from 11am-5pm. You must be in your spot and be ready at **11 AM**. Vendors must keep their displays up until the market ends at 5pm. The event ends at 9 PM and all vendors are welcome to stay until the grounds close at 10pm.

✓ Producers that sell goods should be selling goods created by the Producer. No wholesale products allowed unless approved by Growing South Milwaukee.

✓ All Vendors must provide proper permits to sell

✓ Products sold should match Vendor application.

____ Vendors must be set up by 11 A.M. for Health Department inspection AND market attendees.

____ Vendors must sign up for the Facebook Group. This is where all communication, information and updates regarding the event will be posted.

____ **SMOKING: There is no smoking allowed in the sale areas by Vendors during the event hours.**

____ SPACE RENTAL/FEES: NO refunds will be given if the Vendor fails to show up for the event.

____ INCLEMENT WEATHER: All Vendors are expected to come rain or shine unless dangerous conditions may occur and the event is canceled by Growing South Milwaukee. In this event, an email will be sent AND a post will be made in the Facebook group.

____ SALES TAX: Each Vendor is responsible for the reporting of and the payment to the Wisconsin Department of Revenue of all required taxes resulting from the sales made at the Growing South Milwaukee Flip Side Festival of the Arts.

____ COMPLIANCE WITH LOCAL, STATE AND FEDERAL LAWS: All Vendors are responsible for obtaining necessary county or state health and/or other permits and are responsible for compliance with all state and federal food and drug laws including proper labeling.

____ Growing South Milwaukee specifically reserves the right to assign spaces.

____ Growing South Milwaukee reserves the right to terminate the participation of any vendor who fails to comply with the event rules, without refunding any part of the Vendor's participation fee.

____ Growing South Milwaukee shall not be liable for any injuries incurred by any of the employees or independent contractors of the Vendor during the performance of this Contract.

____ Vendor shall indemnify Growing South Milwaukee against any liability or loss and against all claims or actions based on or arising out of injury to or death of any persons or damage to or loss of property caused by acts or neglect of the Vendor or any of its employees or agents in connection with the performance of this Agreement.

____ Vendor shall not hold Growing South Milwaukee liable for any and all claims of any nature for damage to property or for personal injury including death, which may arise from the performance of this Agreement.

____ Growing South Milwaukee shall not be liable to the Vendor for any expenses incurred by Vendor in connection with this Agreement. Vendor is an independent contractor and is not a servant, employee or partner and Vendor shall have no authority to bind Growing South Milwaukee by and promises representation.

____ This Agreement shall be governed by the Laws of the State of Wisconsin.

____ No waiver, alteration or modification of any of the provisions of this Agreement shall be binding unless in writing and signed by a duly authorized representative of Growing South Milwaukee and the Vendor.

____ This is a non-exclusive event, there may be similar items for sale by other Vendors.

____ Vendor assigns Growing South Milwaukee the right to use the name and likeness of the vendor, its owners, partners, shareholders, officers, directors, employees and agents for the purpose of promoting the market event.

____ Vendor agrees to park where designated by Growing South Milwaukee to maximize parking for market attendees.
