ROAD REPORT

Partial payment to Traut \$2022.50 for swing arm on cap to well for town hall. \$900 deduct & \$1695 add on for water treatment system. Ross Imholte made the motion to pay the partial pay to Traut Wells. Bus Stimmler seconded it. All in favor. Motion carried.

Fill Station paving completed on June 16th, 2020. Put class two on for maintenance on lift.

Axtec scheduled to be here after the 4th of July.

Sent out list of projected future projects on June 2nd, 2020 with recommended years. Mostly all reclaimed. Would be best if Haven township would do their part on 41st Ave. at the same time.

OLD BUSINESS: Clean-up day; officially not rescheduled for 2020.

New Town Hall Update- Pouring cap for safe room this week. Trusses for front are suppose to be ordered, working on stain colors for them. Internet & phone: Arvig: \$240 a month for 50mg of internet for five years. Safeway would add a router. Could minimize the cost of phone if going with Arvig. Could tap into line already going through Travelers. Gary A. will check into to more info on phone. Would have to sign contract.

NEW BUSINESS:

We received two contracts for road maintenance & snow plowing. The first one was for Driveway Services for road maintenance. Bud Stimmler made the motion to accept both bids from Schendzeilos & Son for snow plowing & Driveway Services for road maintenance on a three-year contract. Bud Stimmler made the motion to approve the contract. Ross Imholte seconded it. All were in favor. Motion carried.

David Reetz variance for septic. Ross Imholte made motion to approve, seconded by Bud Stimmler, all in favor, motion carried.

Variance for new septic tank through Bussies septic for Bill Hexler (septic designer) for Jacquelin Anderson on failing system. Asking for 50 ft. setback on a new septic system. Ross Imholte made the motion to approve variance, seconded by Bud Stimmler, all in favor, motion carried.

Abstract for clean up day site- \$1485 to come up with/provide an abstract for site for all parties involved. Approval to Gary Gray to take care of that.

Township Lawyer- not sure where he is at since possible diagnosis of COVID-19.

Any bills that need to be paid right away for new town hall need to be sent directly to Paul.

Wes Scott property- he to sell township because we won't sell him property. Township attorney says he doesn't have leg to stand on, however, township will have to pay legal fees.
