**ROAD REPORT:** Eyk is requesting approval to award the contract to Knife River for the 74<sup>th</sup> St project in the amount of \$123,247.50. Motion by Ross Imholte to approve the bid to Knife River for the 74<sup>th</sup> St project. Second by Kiel Golly. Carried. Eyk will be sending a letter to the resident of White Farm Estates and set a date for the meeting. Our Attorney will be asked to attend the meeting to answer any questions.

## **New Business:**

<u>Brushing on 72<sup>nd</sup> St.:</u> Discussing using chemicals in the right of way before brushing to see if it will last longer. Will check the price of having it done.

<u>Update on County Meeting on Cannabis/opioids</u>. Sherburne County is working on new language for the new ordinance and letting the Townships opt out and having the County take care of licenses and compliance checks.

<u>Approve list of Election Judges:</u> List of Judges were presented to the Board members that will be used to work at the elections. Motion by Ross Imholte to approve, second by Kiel Golly. Carried.

<u>Misc</u>: Deputy Clerk Anderson discussed our need to get a new website as our current site has not been working. Have been checking with other Townships to see what they are using and if they meet our needs.

Motion to adjourn my Ross Imholte, second by Kiel Golly at 7:55. Carried.
