December 16<sup>th</sup>, 2025, Clear Lake Township Board meeting was held at the Clear Lake Township Hall. ### **ROAD REPORT:**

**90<sup>th</sup> Ave LRIP Update:** Eyk has submitted the grant request for 90<sup>th</sup> Ave. He gave a list of the projected prices for the project. The grant ineligible items cost will have to come out of the Township Road and Bridge funds.

Eyk has a resolution that is needed for a minimum maintenance road for a segment of 96<sup>th</sup> Ave SE. Motion by Ross Imholte, second by Kiel Golly to approve Resolution number 25-12-16 for the designation of a segment of 96<sup>th</sup> Ave SE as a minimum maintenance road. Motion carried.

**Chairmans Report:** Received a call from a resident about a snowmobile driving in the ditch in front of his property. That is allowing in the Township right of way.
