PARK & TRAILS REPORT: Walking trails being used quite a bit.

ROAD REPORT

Partial payment to River road fill station resurfacing in the amount of \$9238.78. Under contract so board approval is needed. Ross Imholte made a motion to pay the payment, Bud Stimmler seconded it, all were in favor, motion carried.

New Town Hall Site work partial payment in the amount of \$10,402.96, mostly for concrete flat work out front. Gary Gray made the motion to pay the payment under contract, Bud Stimmler seconded it, all were in favor, motion carried.

Rough estimate of \$2000 to reconstruct south end of handicap parking because of the pounding down of the construction equipment in order to shape that back up.

Township had to do an emergency road closure and realized we could use some cones for instances such as this. Gary Gray approved getting some used cones from Superior for \$300. Bud Stimmler said he would stencil them.

Planning Commission Meeting last week- had demographics coming out for county planning.

New Sign off Co. Rd. 8 for new township hall. Eyk will check into some options.

OLD BUSINESS: Soffit was started for new town hall.

NEW BUSINESS: New Plat Plan for Braun addition was approved by township for Tom Hentges & Wanda Selix.

Mr. Corrigan- river road right a-way issue: both attorneys from both parties look over preliminary draft and once drafted, it would be signed and recorded.

Approve patriot paper as our new legal paper. Bud Stimmler made the motion to approve patriot as our new legal paper. Ross Imholte seconded it. All were in favor. Motion carried.

Approval of election judges for 2020 Primary election. Ross Imholte made the motion, Bud Stimmler seconded it, it was in favor by all.
