Mattresses and spring furniture will be increased to \$30.00. The cost for small trailer loads will be \$25.00 and larger loads will be \$40.00.

<u>Joe Then, Supervisor Haven Township</u>: He was present to discuss road maintenance costs in Sherwood Shores. Chairman Stimmler will set up a meeting with Haven Township to discuss cost for snow plowing & road maintenance.

Eyk and Bud went on a tour of the roads. Eyk presented a future projected road project list for the Township through 2030. Our main project for this year will be the White Farms Estates reclaim and resurface project. The bids will be awarded April 3<sup>rd</sup>.

Eyk also gave a report on the comparisons of costs for various roadway surface treatment costs.
