GENERAL REFERENCES

SECTION 1 - BILLS AND ADVERTISING

No posting or distribution of bills, placards, sinage, advertisements shall be made, distributed or placed within Irvin Park, except for advertisements relating to entertainments or features taking place within the park.

SECTION 2 - BONFIRES PROHIBITED

Building, initiating, burning, or to cause the burning of bonfires within Irvin Park is prohibited.

SECTION 3 - LOUD CONVERSATIONS OR DISTURBANCES

Loud conversations, disturbances or conduct which causes to disturb visitors from hearing or participating in programs or entertainments delivered within Irvin Park are prohibited.

SECTION 4 -DISORDERLY CONDUCT, DRUNKENNESS, PROFANITY, AND LEWDNESS

Disorderly or riotous conduct or assemblage, drunkenness, use of profanity, and indecent language or indecent exposure are prohibited.

SECTION 5 - USE OF VEHICLES

All motor and other movable vehicles while in Irvin Park shall be driven in a careful manner with regard for the safety of people and property and in full compliance with Pennsylvania Law and Title 75 of the Pennsylvania Vehicle Code.

SECTION 6 - TAMPERING WITH PROPERTY

It shall be unlawful for any person, either individually or acting in a business or professional capacity, within the limits of Irvin Park to tamper with or deface any property of the Curwensville Borough or of any other person or entity.

SECTION 7 - PARKING

No vehicles shall be parked within Irvinark except in designated parking areas.

SECTION 8 - DISPOSAL OF DANGEROUS ARTICLES AND REFUSE

Refuse may only be deposited within the refuse containers on the grounds of Irvin Park provided

for the use of patrons of the park. Any individual or entity in violation of this section may be subject to penalties pursuant to the Pennsylvania Code.

SECTION 9 - HUNTING AND SHOOTING PROHIBITED

Shooting of any kind or hunting at any time within Irvin Park is prohibited.

SECTION 10 - CURFEW REGULATIONS IN EFFECT

For the purpose of this chapter and any other ordinance of the Curwensville Borough, Irvin Park shall be regarded as a public place and it is hereby declared that the curfew regulations of the Borough shall be enforced as part of the regulations of Irvin Park.

SECTION 11 - PERMISSION REQUIRED FOR CONSTRUCTION AND DIGGING

No person or entity shall erect any building, wharf or structure, or place poles, posts or foundations therefor, or do any digging of holes in Irvin Park located in the Borough of Curwensville, Pennsylvania, until and unless such person or entity shall have first received a written permission from the Council of the Borough of Curwensville. A request for permission to undergo construction, alter, or dig on any property within Irvin Park shall be made by the person requesting permission and must state the proposed construction to take place and the reasons for the request.

SECTION 12 - VIOLATIONS AND PENALTIES

Any person or entity violating any of the provisions of this chapter shall receive a fine of up to \$300. Failure to pay any fine imposed hereunder will result in further action by the Curwensville Borough as described in Ordinance 480 Alternate Dispute Resolution or any other provision of Borough Code.

SECTION 13 - ALCOHOLIC BEVERAGES PROHIBITED

It shall be unlawful for any person to transport or carry onto, be in possession of or use or consume any alcoholic beverages within Irvin Park or in the West Branch of the

Susquehanna River adjacent thereto.

SECTION 14 - PETS

All pets must be on a leash at all times while in the limits of Irvin Park. All pet owners must remove or clean up all fecal waste deposited by their pets or may be subject to penalty hereunder.

SECTION 15 - SMOKING IN PAVILIONS

There shall be no smoking inside any of the pavilions located in Irvin Park. Any person desiring to smoke tobacco or other legal substance shall smoke no less than six (6) feet from any pavilion.

SECTION 17 - REPEALER

All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith are hereby repealed and rescinded.

SECTION 18 - INVALIDITY

In the event that any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any of the remaining provisions, sections, sentences, clauses or parts of this Ordinance; it being the intent of the Borough of Curwensville that the remainder of the Ordinance not declared invalid shall be and shall remain in full force and effect.

SECTION 19 - EFFECTIVE DATE
