# ORDINANCE 495 ADOPTION OF CODE ARTICLE II

Presented to Council September 24, 2020

Be it enacted and ordained by the Council of the Borough of Curwensville, County of Clearfield, Commonwealth of Pennsylvania, as follows:

# **SECTION 1 - Repeal Obsolete Code**

Repeal Ordinance 431 Insurance For Elected Officials

Repeal Ordinance 240 Recreation Board

Repeal Ordinance 263 Assessments: Penalties for Non Payments

## **SECTION 2 - Amend Code**

Amend Chapter 42 Ordinance 429 Curfew, Sections 42-2 and 42-5(C): Change designation of "Chief of Police" to "Officer in Charge"

Amend Chapter 52 Ordinance 313 Fire Prevention, Repeal Section 52-2 Bureau of Fire Prevention: establishment and duties, and Amend Section 52-3 to remove Definition "Chief of the Bureau of Fire Prevention".

Amend Chapter 56 Ordinance 260 Garbage Collection and Disposal, Repeal Section 56-3(C)Licensing of Collectors and amend 56-3(D) to read as follows:

# D. Collection vehicles.

(1) All persons transporting refuse over the streets and alleys of the borough shall haul and transport the same in trucks the body of which is completely enclosed with wood or metal so as to prevent such refuse from being spilled or blown on any sidewalk, street or alley. In addition, if the same truck is used to transport garbage and ashes or other noncombustible material at the same time, the said truck shall be compartmented, and the combustible and non-combustible items shall be kept separated and shall be separately unloaded at the dump as directed by the party in charge of said dump. Every such truck shall be plainly marked on the cab door on each side of the truck with the name and license number of the licensee operating the same, and all such trucks shall be kept in a sanitary condition at all times.
