**DRAW AGREEMENT:** The hunter gives Big Horn Outfitters permission to apply him/her and use above credit card for the New Mexico state outfitters draw and if successful agrees to hunt with Big Horn Outfitters. A 50% deposit required upon successful draw. The remainder is payable upon arriving at designated camp.

**LICENSING:** The hunter is responsible for all state licensing fees and sales tax. All hunts are conducted in strict compliance with the laws and regulations of the State of New Mexico.

**EQUIPMENT:** The hunter is responsible for a weapon, ammunition, and all personal articles. Outfitter shall provide food, lodging, guide services, field accommodations, field dressing of game and packing to hunting headquarters. The hunter shall provide personal transportation to hunting headquarters unless other arrangements have been agreed to by all parties.

**HUNTER'S PHYSICAL CONDITIONING:** The hunter is solely responsible for their physical condition. Hunts take place in rough terrain at high altitudes! If the hunter has any doubts about his or her ability to withstand strenuous activity at high altitudes, he should consult his doctor. The hunter represents that he or she is an experienced hunter and is responsible for all hunting hazards. The hunter acknowledges that he/she will be required to sign Big Horn Outfitters' Hold Harmless Agreement Pursuant to hunt.
