Event Participant Agreement

Future Legends Cheer & Dance is committed to hosting safe, professional cheerleading and dance competitions.

Participation in these events requires acknowledgment of the physical nature of cheerleading and dance activities.

Participants, coaches, and spectators must comply with:

- Event rules and procedures
- Venue safety policies
- Staff instructions
- Competition guidelines

Future Legends Cheer & Dance reserves the right to refuse entry or remove any participant or spectator for unsafe or inappropriate behavior.



Assumption of Risk

Cheerleading and dance involve physically demanding activities including:

- Tumbling
- Stunting
- Lifting
- Tossing
- Aerial movements
- Rapid directional changes

These activities carry inherent risks including but not limited to:

- Broken bones
- Sprains and strains
- Concussions
- Head injuries
- Permanent disability
- Death

By participating in this event, I voluntarily assume all risks associated with cheerleading or dance activities.

I understand that injuries may occur despite reasonable precautions taken by event organizers.



Liability Release

Medical Authorization

Coach Certification & Team Responsibility

The team's coach or program representative confirms that:

- Athletes meet age and eligibility requirements

- Athletes are supervised during the event

Coaches agree to enforce competition rules and safety standards.

Future Legends reserves the right to disqualify teams violating safety guidelines.



Music Licensing Compliance

All teams must comply with music copyright laws.

Teams certify that:

- Music used for competition routines is legally obtained
- Music edits comply with licensing requirements
- Teams have legal rights to perform their music

Future Legends Cheer & Dance is not responsible for violations of copyright law committed by teams or gyms.



Spectator Liability Notice

Attendance at cheerleading and dance events involves potential risks including:

- Contact with athletes or equipment
- Slip and fall hazards
- Accidents in crowded areas

By entering the venue, spectators assume these risks.

Future Legends Cheer & Dance and the venue are not liable for injuries sustained by spectators except where required by law.



Event Policies

Code of Conduct

Participants and spectators must demonstrate sportsmanship and respect.

Prohibited behavior includes:

- Harassment
- Disruptive conduct
- Verbal abuse
- Intoxication
- Interference with event staff

Future Legends Cheer & Dance reserves the right to remove individuals violating these policies.

Event Changes

Future Legends reserves the right to modify:

- Event schedules
- Competition formats
- Venue assignments



Force Majeure & Event Cancellation

Future Legends Cheer & Dance may cancel or modify an event due to circumstances beyond its control including:

- Severe weather
- Venue closures
- Public health emergencies
- Government restrictions
- Natural disasters

In such situations, refunds or event credits may be issued at the discretion of the event producer.
