LEGAL NOTICE

Annual Election of the  
Guilderland Center Fire District  
December 14, 2021

PLEASE TAKE NOTICE that the Annual Election of the Guilderland Center Fire District will take place on December 14, 2021, between the hours of 6:00 p.m. and 9:00 p.m. at the Guilderland Center Fire house located at 30 School Road, Guilderland Center, New York 12085 for the purpose of:

- Electing one (1) Fire Commissioner for a 2-year term commencing on January 1st, 2022, and ending on December 31st, 2023
- Electing one (1) Fire Commissioners for a 5-year term commencing on January 1st, 2022, and ending on December 31st, 2026
- Proposition to Amend Guilderland Center Fire District Service Award Program as Follows:

THE BOARD OF FIRE COMMISSIONERS OF THE GUILDERLAND CENTER FIRE DISTRICT, TOWN OF GUILDERLAND, COUNTY OF ALBANY, IN A RESOLUTION ADOPTED AUGUST 17, 2021, APPROVED THE AMENDMENT OF THE LENGTH OF SERVICE AWARD PROGRAM, ADMINISTERED BY THE FIRE DISTRICT AND ESTABLISHED FOR ACTIVE VOLUNTEER FIREFIGHTERS OF THE GUILDERLAND CENTER FIRE DEPARTMENT, TO EXTEND THE MAXIMUM YEARS OF SERVICE CREDIT FOR WHICH A PARTICIPATING ACTIVE VOLUNTEER FIREFIGHTER MAY EARN A SERVICE AWARD CONTRIBUTION FROM 40 TO 50 YEARS, EFFECTIVE JANUARY 1, 2022. PROVIDED, HOWEVER, THAT SUCH AMENDMENT IS CONTINGENT ON THE GOVERNOR SIGNING BILL A2239-A / S1091-A INTO LAW BEFORE JANUARY 1, 2022, AND IF THIS BILL IS NOT SIGNED INTO LAW SUCH AMENDMENT SHALL NOT BE EFFECTIVE.

THE CALENDAR YEAR 2021 COST OF THE PROGRAM IS \$30,000, WHICH IS \$1,200 PER ELIGIBLE FIREFIGHTER, PLUS ANNUAL ADMINISTRATIVE COSTS OF APPROXIMATELY \$3,000 AND ANNUAL INVESTMENT

EXPENSES OF \$4,000. THE ANNUAL COST OF THE AMENDED PROGRAM WILL NOT INCREASE AS A RESULT OF THIS AMENDMENT AND IS THEREFORE ESTIMATED TO REMAIN AT \$30,000, OR \$1,200 PER ELIGIBLE FIREFIGHTER, PLUS AN ANNUAL ADMINISTRATIVE COST OF APPROXIMATELY \$3,000 AND ANNUAL INVESTMENT EXPENSES OF \$4,000.

SHALL THE STATED RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS BE APPROVED?

Candidates for District Office of Fire Commissioner shall notify the Board of Fire Commissioners in writing of intent to run for office and send to Guilderland Center Fire District, 30 School Road, PO Box 141, Guilderland Center, New York 12085, no later than November 24, 2021.

All residents of the Fire District duly registered with the Albany County Board of Elections as of November 17, 2021 shall be eligible to vote.
