Article II

I understand that the Risks are relative to my own state of fitness and health, and to the awareness, care and skill, with which I conduct myself while participating in an archery activity.
2. I freely accept and fully assume all responsibilities for all Risks and possibilities of personal injury, death, property damage or loss resulting from my participation in an archery activity. I agree that although ARCHERY ONTARIO has taken steps to reduce the Risks and increase safety at our member clubs, it is not possible for ARCHERY ONTARIO to make archers completely safe.
