# Keynote Presenter - Laura Richards, BSc, MSc, MBPsS and Associates

"Stalking - Homicide Prevention: Understanding Stalking, Risk, Law, Evidence Collection"

Attendees will learn about:

- · Behaviour of stalkers and the impact on their victims;
- Risks and the current national models used for the assessment of risk to victims of domestic abuse, stalking and harassment;
- Legislation relating to stalking and common issues within the Criminal and Civil Justice system;
- · How to effectively support a stalking victim;
- And to explore the psychology of the perpetrator and risk management.

Laura is a renowned international expert on domestic violence, stalking, sexual violence, homicide and risk assessment. After a decade of analysing violent crime at New Scotland Yard Laura became the violence adviser to the National Police Chiefs Council (NPCC). Trained by world leaders as a criminal behavioural analyst at the Behavioural Analysis Unit, National Centre for the Analysis of Violent Crime at the FBI and New Scotland Yard, Laura has applied her psychology degrees to analyse violent crime from a behavioural and preventative perspective.

Laura has a BSc in Psychology and Sociology and an MSc in Forensic and Legal Psychology, and with a background in intelligence-led policing, has been the architect of law reform to better protect victims on six occasions.

Laura is Founder of Paladin, the world's first National Stalking Advocacy Service. Paladin was set up following the highly successful All Party Parliamentary Stalking Law Reform Campaign spearheaded by Laura, which led to stalking becoming a criminal offence in 2012. More recently Laura spearheaded the Domestic Violence Law Reform Campaign to criminalize coercive control. Laura helped draft the new law and the statutory guidance and developed and delivered the first training on the new law in the UK.

Laura was head of the Violent Crime and Intelligence Analysis Unit in the Metropolitan Police Service and continues to advise NPCC, the College of Policing, the Home Office and police services across the UK on public protection.

## **Closing Presenter - Matthew Sandusky**

Matthew Sandusky, Founder and Executive Director of Peaceful Hearts

Foundation, was a victim of childhood sexual abuse from the age of 8 to 17 at
the hands of his adopted father, Jerry Sandusky. Matthew is working to turn his
traumatic personal experience into a mechanism to prevent childhood sexual
abuse and help other survivors heal.

Through his work with Peaceful Hearts, Matthew, raises awareness around child sexual abuse in local communities, supports the life-saving work of children's advocacy and sexual assault treatment centers, and advocates for legislative changes. Matthew works with researchers, clinicians, the media, politicians, social workers, and child protection professionals to raise awareness and improve the quality and availability of services to survivors nationwide.



In addition to his advocacy work, Matthew is committed to empowering and educating children to use their voices and help protect them against abuse. He is working with other advocates to implement an in-school curriculum to empower children to use their voices as a first line of defense, along with parents and teachers.

Matthew is also an accomplished author, chronicling his years of abuse in his memoir, Undaunted: Breaking my silence to overcome the trauma of child sexual abuse, which sheds light on the truth about abuse and the healing journey that a victim goes through to become a survivor.

As an internationally recognized spokesperson, on the topic of child sexual abuse, Matthew is asked regularly to comment on breaking news. He has done a one-on-one interview with Oprah Winfrey, been featured in two documentaries, Happy Valley and Invisible Scars, and is regularly published in major newspapers across the country.

Matthew attended Penn State University, studying Business. He, along with his wife and children, currently reside in State College, PA. Through his work with Peaceful Hearts Foundation, Matthew Sandusky has moved from victim to survivor of child sexual abuse.

Matthew will talk about two topics during this session:

WHEN MALES HAVE BEEN SEXUALLY VICTIMIZED AS CHILDREN
In this presentation Matthew discusses child sexual victimization of boys. He
uses his personal story of victimization as a guide to discuss topics such as:
why males find it difficult to report, myths about being abused as a boy, shame,
how sexual victimization can affect adult relationships, and how therapy can
aide in the recovery process. This presentation is great for any male who was
sexually victimized as a child as well as any loved one of those survivors. AND

#### **EXPLORING SEX OFFENDER GROOMING**

This presentation is aimed at gaining a more complete understanding of grooming. The goal of this presentation is to have the audience establish a more complete understanding of the process and elements of victim and environmental grooming. Matthew uses his own personal story of sexual victimization by his adopted father to show the audience how these techniques are implemented.

## David Delmonico, Ph.D.

Dr. David Delmonico is a Professor at Duquesne University in Pittsburgh, Pennsylvania.

Dr. Delmonico conducts research, consultation, and training on topics such Internet psychology, cybersex compulsivity, cyber-offense behavior, and digital health and safety among youth. Dr. Delmonico has co-authored three books on these topics, the latest of which is titled Illegal Images. Dr. Delmonico presents nationally to treatment providers, probation/parole officers, attorneys, and various community groups on these topics. Dr. Delmonico is the Director of the Online Behavior Research and Education Center (OBREC) at Duquesne University.



This recently updated workshop will provide information on cutting edge technologies used to access sex online. Participants will be introduced to the most recent theories and typologies related to individuals convicted of child pornography crimes. Elements important to the assessment of individuals convicted of child pornography offenses, including specific risk tools, will be briefly discussed. The presenters will review the six treatment issues associated with child pornography offenders and provide creative, practical treatment ideas. The foundation of this presentation will be based on the Risk / Needs / Responsivity model.

She has worked in out-patient, in-patient, military, prison and civil commitment settings. Ms. Griffin is certified in the Penile Plethysmograph, the Abel Assessment for Sexual Interest, the Affinity Assessment of Sexual Interest and the LOOK. Ms. Griffin lectures nationally on the assessment and treatment of offline and online sexual offenders as well as those with sexually compulsive behavior. She has written numerous professional articles on these topics, and is co-author of several books and workbooks. She is co-owner of Internet Behavior Consulting.

Ted Lewis serves as the Executive Director for Side by Side, which is dedicated to creating supportive communities where Virginia's LGBTQ+ youth can define themselves, belong, and flourish. Ted has over a decade of experience advocating for LGBTQ+ youth in high education at UNC Charlotte and the University of Richmond. Ted was recognized for their work by Style Weekly as one of Richmond's 40 under 40 in 2018 and received Virginia Pride's Firework Award in 2019.

Andrea Leon is the Volunteer and Outreach Coordinator at Side by Side. She is an advocate for the LGBTQ+ community, dedicated to empowering youth in social equity and justice. She works directly with youth and youth-serving professionals and organizations in providing access to support and resources for LGBTQ+ youth.



#### Understanding LGBTQ+ Youth within Juvenile Justice

While lesbian, gay, bisexual, transgender, queer and questioning youth make up roughly 5-7% of the youth population, they account for 20% of incarcerated youth. This interactive training focuses on basic understanding of LGBTQ+ identities, risk and protective factors for youth, as well as best practices for supporting LGBTQ+ youth. This session includes information on positive supportive behavior and developing policies and practices to best work with LGBTQ+ youth.

Dr Kerry Beckley is Registered Practitioner Psychologist (Clinical and Forensic),
Associate Fellow of the British Psychological Society (AFBPS) and past Chair of the
Faculty of Forensic Clinical Psychology, BPS, UK. Kerry is an Accredited Schema
Trainer/Supervisor in Individual and Group Schema Therapy. Whilst at Rampton High
Secure Hospital, she developed the Schema Therapy Programme for men with a
diagnosis of personality disorder. She was previously the Project Lead for the Personality
Disorder Offender Pathway Project in Lincolnshire and was previously seconded part time
to the Safer Communities Partnership in Lincolnshire to develop a strategy for supporting
and treating perpetrators of domestic abuse. Kerry now runs her own company providing
expert witness reports and training and supervision in both individual and group Schema
Therapy. She has published and presented on Schema Therapy for many years, both
nationally and internationally




Treating the Trauma: Applications of Schema Therapy to offence focused interventions
This workshop will provide an overview of how Schema Therapy can be applied to
individuals who have committed sexual and violent offences. The first part of the
workshop will consider how offending behaviour can be understood in terms of schema
modes, and how the function of sexual and violent acts links to the persons unmet needs.
Participants will be encouraged to consider how this applies to their own clients, and to
consider how both chairwork and imagery techniques can deepen our understanding of
these functions. The workshop will expand upon how the schema model can be used to
inform risk assessment and wider team working, including the common challenges for
teams in 'holding in mind' their clients vulnerability and risk.

## **Ethics Presentation**

Virginia Behavioral Health Boards Regulations 2020

The Virginia Behavioral Health Boards of Psychology, Social Work and Counseling have recently changed the continuing education requirements for ethics for all licensed and certified practitioners. All Behavioral Health Boards have specified that that ethics continuing education must emphasize ethics, laws and regulations, including the standards of practice set out in regulations of the respective Board.

Questions often arise about whether the "standards of practice" refer to those of a professional association (i.e. American Psychology Association, NASW) or those contained in regulation. Since these Boards discipline practitioners based on law or regulation, the licensee is held to those standards rather than to those of a professional association.


