PERFORMER BOOKING AGREEMENT

This agreement is made on _____, 2026, between

Performer _____

And **ITNS Radio & SWC Global Media, LLC**, of Las Vegas, Nevada, hereinafter referred to as the **"Agent."**

1. EVENT DESCRIPTION

The Agent is booking the Performer to participate in **The ITNS Radio Musicians United Festival**, an interactive virtual concert and entertainment venue.

The virtual venue is designed to provide the look and feel of a live concert experience, featuring a **Main Stage, Box Office, Sponsors, Expo Area with booths, and interactive side stages.**

The venue also includes a **Neon Lounge**, where attendees can interact with performers, other artists, music industry professionals, members of the media and fans.

2. PERFORMANCE & COMPENSATION

There is **no fee to perform** in the festival.

The Performer may earn compensation through **ticket sales, booth sales, and sponsorship sales** generated through the Performer's assigned promotional links.

All payments owed to the Performer will be paid to **ITNS Radio & SWC Global Media, LLC** by the concert venue and then forwarded to the Performer along with a spreadsheet detailing the applicable payouts.

Payment to the Performer will be made **within 10 business days.**

3. PERFORMER COMMISSION

The Performer will be assigned specific links to track ticket, booth, and sponsorship sales.

The Performer will receive **50% of net sales** generated from:

- General Admission and other event ticket sales
- Expo booth sales



- Sponsorship sales

The Performer will receive one **complimentary booth** for personal merchandise sales.

The Performer will retain **100% of merchandise sales** made through their personal booth. Merchandise payments are made directly to the Performer.

4. EVENT TICKET PRICING

The virtual concert venue may accommodate **up to 100,000 attendees**.

Current ticket options are:

- **General Admission:** \$10
- **G.A. PLUS:** \$25, including a download of the concert
- **VIP Backstage Access:** \$45, including a download of the concert

5. PERFORMER RESPONSIBILITIES

The Performer will provide a **video performance** for the festival.

Because the festival is presented online, the Performer is responsible for providing their own:

- Instruments
- Computer
- Camera/video equipment
- Audio equipment
- Internet connection
- Other equipment necessary for the performance

The performance does **not** have to be recorded in a professional studio or venue. However, the Performer agrees to make the presentation as polished and professional as reasonably possible. Performers are encouraged to use the **best lighting, sound, and overall presentation** available to them.



6. MUSIC SELECTION

Both **original music and cover songs** are welcome.

Your concert. Your show. Your music.

7. ATTENDEE CONTACT INFORMATION

The venue will maintain information regarding event attendees, which may include **names and email addresses**.

The Performer will receive a spreadsheet containing available attendee information so the Performer can promote and invite attendees to the Performer's future shows and events.

8. RECORDING & DOWNLOAD

The Performer's Main Stage performance will be **recorded**.

The recording may be offered as a digital download to attendees as part of the applicable event ticket packages.

9. ENTIRE AGREEMENT

This agreement constitutes the entire agreement between the parties. Any prior understanding, agreement, or representation of any kind preceding the date of this agreement shall not be binding upon either party except to the extent that it is expressly incorporated into this agreement.

10. GOVERNING LAW

This agreement shall be construed in accordance with the laws of the **State of Nevada**.
