



Zamavero Ranch hereby agrees to reserve one 2026 breeding to HIT THA FLO ,Reg #5750838, for the mare _____, Reg# _____ at the stallion fee of _____ payable to Zamavero Ranch. The first shipping & collection is included in the stallion fee. Any other shipments needed are _____. Make checks Payable to Zamavero Ranch. The stallion fee includes the non-refundable \$ _____ fee deposit.

ZAMAVERO RANCH – BREEDING CONTRACT

Breeding Fee Deposit: _____ non-refundable deposit due with contract within 10 days of receiving contract payable to ZamaVero Ranch. All other fees must be paid in full 48 hours prior to the first shipment of semen.

1. Receiving a contract does not reserve a place in the stallion's book: spots are reserved when the signed contract is received at ZamaVero Ranch and are on a first returned, first serve basis.
2. A copy of the front and back of the mare's registration certificate must be provided along with this contract. Any semen shipped must solely be used to breed only the mare specified in this contract.
3. If the stallion should die or become unfit for service prior to the mare confirming in foal, ZamaVero Ranch reserves the right to fulfill this contract using available frozen semen. The chute fee is non-refundable.
4. If the mare should die or be deemed unfit to breed, ZamaVero Ranch must be provided with a statement signed by a licensed veterinarian confirming these conditions. In this event, a substitute mare may be designated at no additional charge. In all other cases, a mare substitution fee may be charged.
5. The chute fee includes the first shipment of semen via either: one pickup OR one airline shipment OR one FedEx overnight shipment. FedEx will only be available for cooled semen if approved prior to semen order. Fees for additional shipments are: Pickups \$100, overnight FedEx \$350. Fees for additional shipments must be paid before semen will be sent.
6. If cooled semen is replaced by frozen semen (if available), additional fees may apply.
7. Donated and rebreed contracts will be charged a \$675.00 Chute Fee.

8. The stallion will be collected on a set schedule between February 1, 2026, and June 30, 2026.
9. Diligent efforts will be made to settle the mare; however, if for any reason she does not settle, ZamaVero Ranch shall not be held liable.
10. Mare owner agrees to notify ZamaVero Ranch of the mare's pregnancy status, in writing, within 45 days of insemination. Any association fees incurred for not notifying ZamaVero Ranch are assumed by the mare owner.
11. Semen orders must be placed by 5PM (PST) the day prior to collection/shipment.
Semen orders must be cancelled by 8AM PST the day of collection. If the semen order is cancelled after 8AM PST the day of collection, that collection will be billed accordingly. If it was an additional collection, the mare owner will be charged a fee of \$250. Semen orders must be placed with a ZamaVero Ranch employee – no texting, email, or voicemails will be accepted.
12. There is no guarantee of the semen delivery time or of the semen quality at the time of arrival. In the event of insufficient semen on a particular breeding day, ZamaVero Ranch will ship semen on a first ordered, first serve basis. Depending on demand, owners requesting semen should expect to receive only one dose of semen. If fresh semen is not available, the mare owner has the option of receiving frozen semen if available. Any unused frozen semen remains the property of the stallion owner and must be returned to ZamaVero Ranch at the mare owner's expense. Frozen semen fees are applicable.
13. Shipping containers must be returned to ZamaVero Ranch within 48 hours of receiving semen at the mare owner's expense. A fee of \$50.00 for shipping boxes, \$375.00 for Equitainers, or \$1,500 for a Frozen Semen Shipper will be charged to the mare owner for shipping containers that are not returned within the designated time frame. A replacement fee will be charged for shipping containers that are returned without all internal components.
14. **Embryo Transfer:** This contract provides for one live foal and one breeder's certificate. If twin embryos are recovered, only one chute fee and one stallion fee are to be charged. This will apply only if embryos are put in the same year. If more than two embryos are recovered, then each additional embryo will be on a new contract and charged an additional chute fee and stallion breeding fee. This does not apply to ICSI embryos. It is the mare owner's responsibility to notify ZamaVero Ranch within one week of multiple embryos being produced. Mare owner must report the birth of a live foal within one week of the birth of a foal.
15. **Vitrified (Frozen) Embryos:** Mare owner agrees to notify ZamaVero Ranch that an embryo was vitrified within 72 hours of recovery. Fee schedule for additional embryos will be set in accordance with the future stud fee of the year the embryo is transferred unless otherwise agreed upon up front and in writing by all parties.
16. To obtain a breeder's certificate you must notify ZamaVero Ranch of the birth of the foal. The certificate will not be issued if the account has not been paid in full.
17. Should the mare abort the fetus during pregnancy or should the foal born to the mare not stand and nurse without assistance within 24 hours of birth, the mare owner shall be entitled to a rebreed applicable only to the season immediately following the season set forth in this contract. In this event, the stallion owner and ZamaVero Ranch's sole liability and obligation shall be the granting of the rebreed. The rebreed shall apply only if ZamaVero Ranch is notified within one week of the mare palpating open or of the death of the foal. The notification must include a signed statement from a licensed veterinarian

stating the cause of abortion or the foal's cause of death. An abortion or death that results from any act or omission from the mare owner will void the rebreed. The mare owner will be required to pay a chute fee for the rebreed. Second-year rebreeds will be at the discretion of ZamaVero Ranch and additional breeding fees may apply. Rebreeds will only be honored when efforts have been made to breed the mare. Carryover contracts will not be allowed without prior approval. Comp breeding contracts are not subject to the live foal guarantee.

18. The stallion owner reserves the right to participate or not in any incentive program, with or without notice to the mare owner. Requests by the mare owner for nominations/enrollments to additional incentive programs will be at the discretion of ZamaVero Ranch, and if approved, the mare owner will be required to pay all fees.
19. All fees (except the breeding fee) are subject to change without notice and the mare owner is subject to current fees in effect.
20. This contract grants ZamaVero Ranch a security interest in the mare, any foal born to the mare as a result of this breeding, and the proceeds of any sale of the mare or its foal, to secure payment of any and all fees due pursuant to this contract.
21. The mare owner shall hold ZamaVero Ranch harmless of any accident, injury, theft, disease, sickness, or death suffered by the mare and/or foal, or any action whatsoever arising out of, or connected in any way with, shipped semen breeding. This includes but is not limited to any claims of damages or injury that may occur to any person or personal property.
22. Any dispute related to this contract shall be construed, governed and interpreted by and in accordance with the laws of the State of **California**. If any action or arbitration is brought to enforce or interpret the terms of this contract, the venue shall be **Riverside County, California**. If it should become necessary for ZAMAVERO RANCH to enforce its rights under the terms of this contract, including but not limited to the collection of any fees due, the mare owner will pay all expenses and costs, including reasonable and necessary attorney and legal fees, incurred by ZAMAVERO RANCH and/or the stallion owner.
23. This contract is non-transferable or assignable without prior written consent from ZamaVero Ranch. Any changes on this contract without written permission from ZamaVero Ranch will make the contract null and void.
24. Payments must be made with U.S. dollars via check, credit card, or wire transfer. Breeding Fee checks, chute fee, and all additional shipment fees are payable to ZamaVero Ranch. Additional fees apply for credit card charges. Mare owner will be responsible for paying any credit card or wire transfer fees that may be charged to credit the funds.
25. This contract completed and signed, along with all requested documents, forms and fees, must be received by ZamaVero Ranch 48 hours prior to ordering semen.
