1. I am concerned for my protection from arbitrary application of domestic with the intention of frustrating the legal process and access to our Courts of Law uninhibited where I have raised matters concerning our Constitution of the Commonwealth.
2. I am concerned for my safety noting that no specific or direct threat has been encountered however, the nature of my legal claim would be reasonable to conclude there is a prima facie risk that would exist.
3. For me, it is very clear that my ability to live free from tyranny or arbitrary enforcement of domestic law in this Country will be forever compromised and I do not feel that it would be reasonable to consider that I could without such conduct. Thus, I do consider myself a political refugee and would be open to denouncing my citizenship within the Commonwealth of Australia through vitiation of a course of Conduct by the Commonwealth Government of Australia and several State jurisdictions.
4. Part of my claim is under section 51 of the Constitution xxix External affairs relating to International Convention against Corruption in force within the Commonwealth of Australia and the International Convention against Torture. There is a conflict of interest within the Court I am to file this witnessed material as the Court registry is named as a Respondent and it is anticipated access to the Court will feature arbitrary interference in contravention of these treaties.
5. I expect I will not receive a response and I expect to be continually ignored and I fear that I will be placed via arbitrary means into prison, again, and not one person on the planet will know let alone care to intervene.
6. This is as genuine and authentic as my words and witnessed documents can do and I fear for my wellbeing, safety, and liberty.

ADDRESSING MENTAL HEALTH STIGMA HEAD ON

Mental Health and Wellbeing Act 2022 (Vic)

(2) A person is not to be considered to have mental illness by reason only of any one or more of the following—

- (a) that the person expresses or refuses or fails to express a particular political opinion or belief;
- (b) that the person expresses or refuses or fails to express a particular religious opinion or belief;
- (c) that the person expresses or refuses or fails to express a particular philosophy;
- (d) that the person expresses or refuses or fails to express a particular sexual preference, gender identity or sexual orientation;
- (e) that the person engages in or refuses or fails to engage in a particular political activity;
- (f) that the person engages in or refuses or fails to engage in a particular religious activity;
- (g) that the person has engaged in a certain pattern of sexual behaviour;
- (h) that the person engages in conduct that is contrary to community standards of acceptable conduct;
- (i) that the person engages in illegal conduct;
- (j) that the person engages in antisocial behaviour;
- (k) that the person is intellectually disabled;
- (l) that the person uses drugs or alcohol;
- (m) that the person has a particular economic or social status or is a member of a particular cultural or racial group;
- (n) that the person is or has previously been involved in family conflict;
- (o) that the person is experiencing or has experienced distress;
- (p) that the person has previously been diagnosed with, or treated for, mental illness.
