- Occupation: Paramedic (10 years) (Corruptly and unlawfully suspended as a reprisal for exercising workplace rights)
- Family: One child Lio Ferrara DOB: 21/08/2013 (Direct/Indirect Parental Alienation arising from Poverty and family breakdown)
- Finances Assets: Subaru Outback 2016, no income, no social security (punitive measure for not complying with obligations, under protest)
- Health: Recently discharged Adult Psychiatric facility 14/11/2022 Principal Diagnosis: Acute Adjustment Disorder, Self rated health as poor
- Criminal History: Unlawful Assault (2016) a result of ex-wife psychological manipulations, Persistent Contravention Family Violence Order (No physical violence 2017) no one believed my version of events, Intentionally causing Damage to Police Vehicle (2022) Yelling at them to shoot me

BRIEF AND CURRENT STATE OF MIND

1. I'm sorry. I know there are so many people around the world who are facing atrocities and suffering one hundred times more than I am. I am writing this as my last attempt. I have only recently been discharged from a Psychiatric unit and I just don't know how much longer I can continue. I am being alienated from my son by poverty because I can't provide safe shelter, and food let alone basics. I have been self-destructive in actions because I smashed a police car window and screamed at them to shoot me because I can't kill myself, and then I was put in jail, the magistrate didn't acknowledge me and they said I declined a lawyer.
2. While in Prison they tortured me and put me in solitary confinement for 3 to 4-day stints and a total of 12 - 14 days in total. The notes, and letters to the Governor while inside went "missing" I only got the one I have attached by sending it to a lawyer and getting them to email it to me. One time because I refused to say "I am not going to kill myself" in defiance they forced handcuffed me (would have pepper sprayed me had I not just been on the phone to the ombudsman) and Carried me to solitary. Put the cuffs through the chute placed his baton in so I couldn't move my hand, forcibly cut my clothes off and pushed the door so I was forced inside. Because I was depressed and suicidal at times because of the shame guilt and despair that I have been reduced to an animal and no one believes me all my friends are gone and I don't feel human anymore. I just want someone to kill me because if they are going to cheat and leave me with nothing and then expect me to get over it then I can't, I just can't go on and get over it.
3. I have emailed the perpetrators and said I would hang myself and attempted several hangings last year but my body would freeze when it came time to step off or bail out because I'm a coward and its humiliating because now I get dismissed oh it's just personality disorder despite not being formally diagnosed.
4. Recently I emailed perpetrators asking them to kill me because that would be the humane thing to do and an act of compassion but each time I get devastated because at every point they do not acknowledge being human just risk management and mitigation to silence people. I can't unknow that Australia is corrupt.
5. If Australia wants to be part of the treaties then it means doing what you signed you would do even if it causes a loss because that's what you promised you would do. Australian Government should withdraw from the treaties because is devastating to have hope in laws and rules will be applied fairly and equally and then you see that behind the curtain they are not. Citizens wouldn't then have a false hope. My world view is shattered and I will never get that back.
6. I just miss living with my son so much. I miss helping people as a Paramedic, I was good at my job and believe in the psychosocial model. I miss being proud to be Australian but now it makes me feel sick and I have to get the southern cross tattoo burnt off or cut out. I may have been naive but I believed that someone would have my back when I made the whistle blower and Public Interest Disclosures but it's all fake.
7. Please I don't want to be Australian anymore I want to denounce my citizenship. I would rather be "stateless". I can't believe or trust in the Australian Government again and I just want to die all the time. It fluctuates, right now it's about a 4/10 but before the recent discharge it was 9/10 and then time becomes unbearable because the dumbest and only idea I come up with now is to just starve myself to death intentionally and that is painful and takes ages. I just ... I could never let a person suffer anything like this. Even if I don't know if you respond or not I want to thank you for saving people.. Your reports and material provide hope when it feels like there is none. Thank you to each of the Rapporteurs and sacrificing to carry the burden of those horrible acts because I know as a Paramedic those scenes never go away and stay with you for life.
8. I even contacted Australia's FASSTT and they never replied. Maybe they don't exist? I don't know.
9. The ADHD makes it hard for me to concisely state my complaint so people can easily get the main points. Time after time of requesting lawyer assistance they would get mad because they couldn't get the easy summarised information they wanted fast enough. I have exhausted all avenues for legal representation. So I have been doing it myself but I am not sure I will hold out long enough to be able to finish. I miss the life me and my son had and I miss him, It kills me that we might be drifting apart.
10. Even if no one reads this or responds, it helps anyway. Thank you for doing what you do.

12. *A communication related to a violation of human rights and fundamental freedoms is admissible, provided that:*
 - It is not manifestly politically motivated and its object is consistent with the Charter of the United Nations, the Universal Declaration of Human Rights and other applicable instruments in the field of human rights law;*
 - It gives a factual description of the alleged violations, including the rights which are alleged to be violated;*
 - Its language is not abusive. However, such a communication may be considered if it meets the other criteria for admissibility after deletion of the abusive language;*
 - It is submitted by a person or a group of persons claiming to be the victims of violations of human rights and fundamental freedoms, or by any person or group of persons, including non-governmental organizations, acting in good faith in accordance with the principles of human rights, not resorting to politically motivated stands contrary to the provisions of the Charter of the United Nations and claiming to have direct and reliable knowledge of the violations concerned. Nonetheless, reliably attested communications shall not be inadmissible solely because the knowledge of the individual authors is second-hand, provided that they are accompanied by clear evidence;*
 - It is not exclusively based on reports disseminated by mass media;*
 - It does not refer to a case that appears to reveal a consistent pattern of gross and reliably attested violations of human rights already being dealt with by a special procedure, a treaty body or other United Nations or similar regional complaints procedure in the field of human rights;*
 - Domestic remedies have been exhausted, unless it appears that such remedies would be ineffective or unreasonably prolonged.**National human rights institutions, established and operating under the Principles Relating to the Status of National Institutions (the Paris Principles), in particular in regard to quasi-judicial competence, may serve as effective means of addressing individual human rights violations.*
