Dear Reece Storme Ferrara,

You have made a complaint to the Commission against the State of Queensland (Queensland Police Service), Snr Constable Justin Dickinson, Snr Constable Kyle Jordan, and Snr Constable Scott Hill. That complaint has been accepted under section 141 of the *Anti-Discrimination Act 1991* on the basis of impairment discrimination in the area of State laws and programs.

Please note that this is the Commission's characterisation of the complaint and that a complaint is accepted as a whole. If the complaint is not resolved through the conciliation process and the complaint is referred to the Tribunal (Queensland Civil and Administrative Tribunal), then the parties and the Tribunal are not bound by the Commission's characterisation of the complaint.
