Re: Mr Jacob (Jake) Ferrara

My name is [REDACTED] and I am a Clinical Psychologist. I have been practicing as a consultant at Diamond Valley Clinical Psychology (DVCP) for 6 years. During this time I have worked with various clients experiencing psychological distress due to a multitude of interpersonal problems and mental health issues. Additionally, I have assisted individuals, couples and families to alleviate psychological distress and improve their daily functioning.

REASON FOR REFERRAL

Mr. Ferrara was referred to me by his General Practitioner following a decrease in his mental health, which included symptoms indicative of Posttraumatic Stress Disorder (PTSD). At our initial session on the 22nd of March 2016 it was determined that Mr. Ferrara met the criteria for Complex PTSD. He recounted multiple traumas including ongoing physical violence perpetrated by his former wife, [REDACTED]. Furthermore, following our initial session Mr. Ferrara attended [REDACTED] Psychiatrist, and has been prescribed medication to alleviate the symptoms of PTSD, which include hyper vigilance, hyper arousal and re-experiencing of trauma (intrusive images and nightmares).

TREATMENT

Mr. Ferrara currently attends psychological sessions on a weekly basis and presents as highly motivated to improve his mental health. Our treatment focus has been predominantly Trauma Focussed – Cognitive Behavioural Therapy and collaboratively we developed a hierarchy of traumas, which included physically violent acts perpetrated by his former wife, [REDACTED].

Additionally, Mr. Ferrara has discussed his conflictual relationship with his former wife, [REDACTED]. He described her as demonstrating a cluster of behaviours including fear of abandonment, emotional instability, inappropriate intense anger and impulsivity that are typically indicative of personality based difficulties. Whilst it is inappropriate for me to diagnose [REDACTED] it would appear from Mr. Ferrara's descriptions that she might meet the criteria for Borderline Personality Disorder (BPD). Furthermore, He reports that due to her intense anger he feared for his life at times in the relationship, and since their separation, in October 2015.

Empirical research consistently recommends that family members, and people in any type of relationship with a person with BPD, set limits, boundaries and consequences for inappropriate behaviours. As such I have encouraged Mr. Ferrara to do so. Additionally, I have recommended to him that he have zero tolerance for any psychological or physical threats from his former wife and to report any breaches of the IVO to police. I also explained that when Mr. Ferrara changes his responses to his former wife, and starts to

become assertive, there is a high likelihood that she will escalate in her problematic behaviours . It would appear that this has in fact occurred with [REDACTED] perceiving consequences and limits as control. In my clinical experience this is not unusual in someone with a personality disorder.

In my clinical opinion Mr. Ferrara does not pose a physical or psychological threat to his former wife. He advises that he seeks to maintain a respectful relationship with her in order to facilitate contact with his son, [REDACTED] which will enable them to parent him to the best of their abilities.

Diagnosis:

In my opinion Mr Ferrara has likely suffered an acute adjustment disorder. He began to manifest symptoms of this in the last six to twelve months. These were likely sub-threshold and not at that time substantially impacting on work functioning. This appears to be predominantly in relation to marital stressors. He experienced high levels of subjective stress and a generally reduced resilience.

Aside from extreme situations, in which the abuse is unrelenting, the perpetrator will at times profess their love, offer gifts, show kindness and express remorse.

Germans are a bunch of BLACK. AND WHITE whinging proper stress heads. I dont really like them and for sure Hate her mum and will have nothing to do with her.'

I would push back and wear what I want, however and like always, she would escalate to places where I refuse to go (escalate into violence) so not only did I have to submit to keep the peace for [REDACTED] but I had to submit because the fight was so draining.

[REDACTED] He told me that he tried to spend a lot of his teenage years out of the house so that he could get away from his father (as well as his brother). He told me that he has three older brothers, but his next older brother used to hit him and was quite aggressive.

He is separated from his [REDACTED]-born wife [REDACTED] aged 31. [REDACTED] and son [REDACTED] aged 3, live in Briar Hill. Jannina is currently studying English. They got married to each other on 6 December 2014 and separated in October 2015.

During the interview Mr Ferrara told me that he first met [REDACTED] in Thailand in January or February 2012. He then visited her in [REDACTED] for one month in 2012 and she came to Australia for one month. She then came and lived in Australia in September 2012, and they lived together for about five or six months. He told me that he resigned from Ambulance Victoria in September 2014. He then went to live in Germany for four to five months with Jannina and son [REDACTED]. He lived in Germany on the border of Switzerland and France. He lived there between September 2014 and February 2015. During that period of time he was still casually employed by Ambulance Victoria.

During the interview, Mr Ferrara told me that his [REDACTED] with [REDACTED] has been "problematic from the start". He told me that in his opinion, [REDACTED] has an undiagnosed personality disorder, possibly Borderline Personality Disorder. He told me that there was often a lot of conflict in their relationship. In his own words he told me that he never knew when the next argument was going to happen, and he referred to her alleged "impulsive rage".

Habits:

He does not smoke cigarettes. He drinks alcohol very infrequently, about four or five times a year.

He does not use illicit/recreational drugs.

He told me in his own words that over his time of "misconduct" he was taking intranasal Fentanyl from his workplace. This was before 22 December 2015. He told me that his use of intranasal Fentanyl commenced after his son was born. His son was born in August 2013. He told me that his use of intranasal Fentanyl commenced when he returned to Australia in or around September 2013. Therefore, it went for a duration of about two years and three months. He told me that he never had "withdrawal symptoms during that period of time. He told me that his use of intranasal Fentanyl was dependent upon his psychological state at the time. From his perspective, he told me that he used intranasal Fentanyl in order to sleep and in order to "fast forward time" until he could next see his son. He told me that he was working a significant amount of overtime at work. However, he told me that when he could not get overtime at work, his grief regarding not seeing his son was significant and therefore he used intranasal Fentanyl at those times in order to "escape" he said.

He told me that he reported his "misconduct" (the use of intranasal Fentanyl, taken from his workplace) to his employer on 22 December 2015. He was stood down on full pay pending an investigation.

His wife and son were living in Briar Hill.

He told me that he used to drive to Traralgon from Briar Hill, sleep in his car, and then drive back (when he was doing dayshift). When he did nightshift he used to sleep at the branch.

He told me that his employment was officially terminated on 14 August 2016.

CURRENT PSYCHOLOGICAL AND EMOTIONAL SYMPTOMS AND PROGRESS:

He told me that in or around mid-February 2016 (about two weeks before 28 February 2016) he was experiencing recurrent nightmares of his ex-wife continuously punching him (Jacob) in the face. In addition, he was experiencing nightmares of himself as a teenager involving his father becoming angry with him and his father chasing him out of the house and down the street.

He told me that he sees [REDACTED] psychiatrist. The frequency of sessions has depended upon the fluctuation of his symptoms. His symptoms have fluctuated a lot. He was seeing [REDACTED] on a fortnightly basis and currently sees him monthly.

He has been seeing psychologist [REDACTED] since their first session in or around April 2016. He saw Ms [REDACTED] on a weekly basis whilst he had a mental health plan. He then had to self-fund the sessions. He told me that he received an early payout from his superannuation fund in order to fund his own treatment for his mental illness. He currently sees Mr Walker on a fortnightly basis.

He originally saw Dr Warwick/Rick [REDACTED] to submit his WorkCover claim but now he sees his general practitioner Dr Greg [REDACTED] on a monthly basis for certificates of capacity.

He told me that he has been admitted to a psychiatric ward on two occasions this year.

He initially was admitted to the Austin Hospital with "severe PTSD" when he drove his car into a tree. He was admitted for three days.

He was then admitted to Broadmeadows Adult Psychiatric Unit with "depressive symptoms" and "psychological exhaustion" for three days.

He told me that his nightmares returned about six weeks ago.

I asked him about his leisure activities and hobbies. He enjoys exercising. He does push ups and sit ups. He occasionally runs. However he cannot afford a gym membership at present. However he told me that he has been allowed to use the gym if he helps to train some other people who attend there.

He told me that he is not socialising at present and that he is isolating himself from friends.

I asked him about his emotional state and he said "I take each day by day." He told me that he is prone to having symptoms of "PTSD" or "depression".

I specifically asked him what he meant by symptoms and features of "PTSD".

He told me that he has "flashbacks" and that the flashbacks "could be of anything ... [REDACTED] punching me, dad yelling at me, being stuck in a house and trapped with a violent patient trying to kill me, faces of dead people". (My comment: In other words, he was referring to alleged previous physical assaults from his ex-wife, to physical and verbal abuse from his father during adolescence, and to alleged distressing and traumatic incidents during the course of his employment.)

He told me that he experiences a type of screen in his upper field of vision that is like a movie playing with all of the "traumatic events" that he has experienced. He told me that when he experiences these flashbacks he becomes scared, anxious, he develops tightness in his chest, difficulty breathing, and feels the need to escape.

I asked him what he meant by feeling depressed. He told me that when he feels depressed he feels hopeless, helpless and overwhelmed.

He told me that he initially put on 10kg in weight from March 2016, over a period of six months, when he started taking Quetiapine. However he told me that due to his severe financial strain, and living on only "basic food" he has lost all of that weight and probably an extra 2kg to 3kg.

He told me that his interests, energy and motivation fluctuate a lot. He told me in his own words that on a good he gets stuff done, but on a bad day he feels like sleeping all day.

I asked him whether there is anything that cheers him up, gives him enjoyment or pleasure to which he replied "My son is the most important protective factor in my life." He also told me that he enjoys gardening and exercise.

I asked him how he sees the future to which he replied "I know there's a light at the end of the tunnel. Until that, I haven't been medically cleared to work."

At the end of the interview on specific questioning, he told me that the psychiatric registrar at Austin Hospital officially diagnosed him with PTSD on 2 March 2016.

He understood that it was mainly due to personal factors, but also due to "traumatic jobs attended to as a paramedic".

He told me that during the first session with Ms Walker in April 2016 they went through a "hierarchy" of the traumatic events that he had experienced in his life. After that first session in April 2016, he told me that he started experiencing flashbacks of "dead people at work" as well as flashbacks and nightmares of being trapped in patients' bedrooms, and flashbacks and nightmares of other distressing, dangerous and traumatic incidents and events during the course of his employment.

MENTAL STATE EXAMINATION:

Appearance and Behaviour:

On mental state examination, the worker/claimant Mr Jacob Ferrara appeared a pleasant, polite, and punctual 33 year old man who attended the interview alone.

He gave a detailed and articulate history.

Speech:

Affect:

The quality of his affect was mildly to moderately concerned and worried as well as mildly anxious but not specifically depressed during today's interview itself.

Thought Stream and Form:

His thought stream was within normal limits. There was no formal thought disorder.

Thought Content:

The content of his thinking revealed:

1. references to pre-existing, childhood and adolescence, verbal and physical abuse perpetrated by his father, as well as family of origin adversity;
2. references to a difficult, problematic and strained relationship with his (ex) wife;
3. previous "grief" regarding time spent away from his young son [REDACTED]
[REDACTED]
4. previous abuse of intranasal Fentanyl including obtaining that medication from the place of his employment reportedly, from the claimant's perspective, as a form of self-medication for his emotional distress, related to his "grief" above and perhaps other stressors;
5. his "confession" regarding his misconduct (above) and resultant disciplinary action from around 22 December 2015;
6. the onset of reported Post-Traumatic Stress Disorder symptoms and traumatisation features including thoughts, triggers, reminders, flashbacks, bad dreams and nightmares regarding pre-existing and unrelated traumata in his life as well as reported distressing, frightening and traumatic experiences and incidents during the course of his employment.

"There is a complicated history of traumatic experiences at different life situations, both within the family of origin, in marriage, and in the workplace. He has vivid memories of being physically and emotionally abused as a child. While working as a paramedic he was exposed to multiple traumatic incidents. The one in 2012 was particularly traumatising. He was bullied at work in September 2015. ... An acute stress reaction with PTSD kind of symptoms is possible. However given the longitudinal history he may have chronic PTSD."

15. I read the detailed psychiatric report of Dr Gregor Schutz dated 8.11.15. I note reference to an acute Adjustment Disorder.
16. I read the psychiatric report of Dr N Dharwadkar dated 27.4.16 referring to a chronic Major Depressive Disorder with Post-Traumatic Stress Disorder symptoms.
17. I read the supplementary report of Dr Dharwadkar dated 6.6.16. I note his opinion that the suspension and the termination, which were based on some personal issues/factors, were the predominant factors for incapacity/cessation of work.

DIAGNOSES AND DISCUSSION:

This is a very complex and complicated case.

The worker/claimant Mr Jacob Ferrara is a 33 year old separated father of one who resides alone in a rooming house in Bundoora. He has done so since March 2016. His ex-wife [REDACTED] and 3 year old son [REDACTED] reside in Briar Hill.

He was employed as a paramedic (advanced life support) for his pre-injury employer, Ambulance Victoria. He qualified as a paramedic at the end of 2008 and commenced employment with Ambulance Victoria in or around February 2010. Up until about October 2015 he was based at Traralgon. He most recently worked at the Warragul branch up until his last day on 22 December 2015. On or about that day he "confessed" to misconduct involving the "theft" of S8 drugs of addiction from work and was stood down, with full pay, pending an investigation. He has remained off work. His employment was terminated by Ambulance Victoria on or about 14 August 2016.

The relationship with his ex-wife has contributed in a significant and substantial way to his psychiatric, psychological and emotional state since early 2012, and has continued to do so during 2015 and this year (2016). In addition, the claimant experienced significant "grief" and emotional stress particularly in the context of not being able to be in regular contact with his son at various times since his son was born in August 2013.

On the one hand, despite the claimant's past and more recent adversity, traumata and psychosocial stressors, he partly (but not completely and not largely) overcame them by working hard, applying himself with his studies, and taking his occupation as a paramedic - to his credit - very seriously.

In addition, it seems to me that he has suffered from a chronic, recurrent, though fluctuating and intermittent, mixed depressive and anxiety syndrome over the years due, particularly to:

1. his childhood and adolescence;
2. to a lesser extent, his experiences of some alleged bullying during his years of studying; and
3. his relationship with his (ex) wife.

During the interview today the claimant referred to several reported stressors that have occurred during the course of his employment:

1. obtaining intranasal Fentanyl from his place of employment from about September 2013 and the use of intranasal Fentanyl;
2. alleged/perceived/reported "bullying" during the course of his employment during the second half of 2015 from August 2015;
3. reporting/"confessing" his "misconduct" (theft and use of Fentanyl) to his employer on or about 22 December 2015 resulting in "disciplinary action" in which he was stood down with full pay pending an investigation;
4. the development of reported Post-Traumatic Stress Disorder symptoms and traumatisation features including thoughts, triggers, reminders, flashbacks, bad dreams and nightmares of reported/claimed incidents and experiences of traumata during his employment/occupation as a paramedic with Ambulance Victoria (from February 2010).

Regarding the above issues I make the following comments.

It is very difficult for me to comment about the Fentanyl issue in retrospect, because it has become clouded by inter-current factors and has reportedly been inactive since late December 2015.

He has significant and substantial premorbid vulnerability and premorbid psychiatric stressors and conditions though he also has a number of ego strengths and positive prognostic factors. His treatment/management rationale is a matter of treating his pre-existing and unrelated psychiatric conditions, containing those conditions as well as containing his vulnerability factors, and harnessing his strengths.

Ms Ferrara's father aged fifty six, is a house painter, he has had several partners and as a child he was an unreliable contact. The attempts at contact continued until she was twelve. She reports that she hated him but from the age of twenty she forgave him and has enjoyed a good relationship with him and he has been supportive with regular contact. She reports that he is trying to be a better grandfather to [REDACTED] than he was a

father to [REDACTED] She describes her father as very stubborn and initially quiet when you meet him, his recreation is his dog and soccer. He has had chronic health problems, his first Myocardial Infarction was at the age of thirty two.

[REDACTED] remembers fights between her parents about her father's irregular contact, she also reports that she was jealous of her step father and wanted to be rid of him but she remains in contact with him now. 3. At the age of twenty six, she began a relationship with Mr Storme aged twenty eight, because he was cute and fun and made her laugh and was caring. They married when she was twenty nine, because they had a child and the marriage lasted for ten months and ended because [REDACTED] felt he was "crazy", lying, cheating and taking drugs in front of [REDACTED] and generally acting like a child.

There is one child to the relationship, [REDACTED] aged four, who is healthy.

4. At the age of thirty one, [REDACTED] began a relationship with Ali, aged twenty eight, who she describes as "like my best friend". He works with his father as a mechanic and they are not in a defacto relationship and he does not have children of his own. [REDACTED] became tearful during this part of the interview because so many questions were being asked.

At the age of thirteen, [REDACTED] began smoking marijuana, which from the age of fifteen, was regular until 2011. She said that she has tried everything except ice and heroin, including ecstasy, speed, cocaine and mushrooms but has not used these for many years, alcohol has never been a problem.

[REDACTED] is living alone with [REDACTED] she reports that she is isolated with friends and family overseas.

Recreational History

[REDACTED] reports that she does have a few friends here in Australia and she enjoys meeting them.

Discussion

[REDACTED] reported that she has produced Urinary Drug Screens, all of which were clear. In relation to concerns about her management of [REDACTED] she reported that for fourteen months he did not sleep and this she found extremely stressful and did at times feel like hurting him but withdrew to her balcony, took deep breaths and then came back in to cuddle him and she has been working on learning how to be more calm with him and being more patient. She denies denigrating the father in front of the child. She denies hitting him or locking him in his room. She admits slapping Mr Storme when he was unfaithful and when he was using drugs and she reports that the relationship with Mr Storme's [REDACTED] was never easy. She reported that she was prescribed Cymbalta by her general practitioner after Mr Storme told him to prescribe and this she stopped during pregnancy. [REDACTED] also admitted that she had made threats to kill Mr Storme when he wanted to come to Bali with her and her friends because she was so angry, it was never something she had planned to act upon. She denies threats to leave Australia with [REDACTED] believing that Australia is a place where she wishes to stay and that she is not homesick although she does report missing her friends and family. In relation to reports in the Court papers about her current boyfriend and his drug use, she insists that he uses marijuana socially with his friends but never in front of her.

As reported [REDACTED] has problems with managing anxiety and emotions, these issues are remediable with appropriate assessment and treatment. [REDACTED] she would, in my opinion, benefit from working with a clinical psychologist to acquire new strategies.

There was also an incident where he was supposed to stay with ■■■■ but it was changed last minute and I told him that mumma did it because she loves you and doesn't want you to get sick. He then asked "so mumma likes me?"

Erica Watchorn is leaving and we have been referred to Dr Emma Little who is considered an expert in her field. She will continue treatment of ■■■■ for the coming years to deal with his anxiety, hypervigilance, confusion about who lives him and what love is and his emotional regulation and I will send invoices to you for payment.

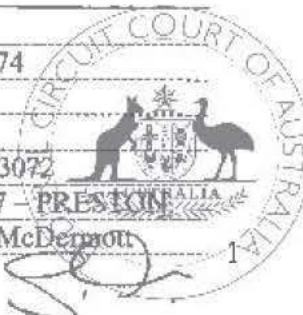

I further note that the father's Application in a Case for an order that the [REDACTED] be restrained by injunction from allowing the child [REDACTED] born on 21 August 2013 to come into contact or proximity with Mr [REDACTED] was also dealt with by the orders made by consent at the hearing of the matter on 22 February 2018. I refer to paragraph 9 at page 13 of the father's Outline of Case Document filed on 20 February 2018 wherein the father sought an order in exactly the same terms. The application for that order was opposed by me and by the Independent Children's Lawyer and as a result no orders were made in those terms or to that effect.

RE: FERRARA - FAMILY LAW MATTER

We refer to the above matter and note we have not received any response from your office to our letter of 13 May 2016.

Your client contacted the writer directly by telephone yesterday to notify us of her intention to collect the child [REDACTED] passport to facilitate her travel to Bali with [REDACTED]. The writer confirmed that arrangement, but otherwise indicated that we were not in a position to discuss substantive matters with your client in circumstances where she has legal representation.

Your client did indeed attend our office this morning to collect [REDACTED] passport. Unfortunately, her conduct while at our office was irrational and abusive.

When we stated to [REDACTED] that we only had instructions to release [REDACTED] Australian passport (not his [REDACTED] passport), your client verbally abused our receptionist. She furthermore proceeded to damage a computer at our reception station by forcefully knocking the screen from the desk, and physically assaulted our receptionist when she snatched the passport and ran out of our office.

Despite numerous requests, your client refused to sign a receipt confirming that the [REDACTED] Australian passport had been released into her possession. Your client also tore up a photocopy of her photographic ID that we had taken to confirm her identity. We have been able to salvage that photocopy of [REDACTED] passport for our records.


It goes without saying that your client's conduct was appalling and has left our office staff shaken and distressed. We have prepared an Incident Report and we are seriously considering reporting your client's conduct to Victoria Police for investigation.

Under no circumstances is your client to attend our office again. We are not prepared to expose our staff to a further episode of such irrational and abusive behaviour.

It also goes without saying that our client is concerned for Lio's welfare in your client's care given her conduct and what would appear to be her complete lack of control over her impulses, anger and aggression.

We enclose herewith Receipt which we ask that you have your client sign confirming for our records that [REDACTED] Australian passport was released to her by our office this morning. You will appreciate that it is standard practice for a legal firm to require a signed receipt for any document released from its Deeds Register confirming the date and identity of the person that collected the document. We ask that the signed and dated receipt be returned to us as a matter of urgency.

I'm sorry if this letter isn't written perfect, English is my second language.

My statement to the incident at the 27.5

I'm very disappointed that the situation got misspresented. It's my right to ask why I don't get my sons passport.

I didnt attacked the receptionist, I just took the Passports of my son. My husband took them from my rental house without my permission.

The reason I took them was because she didn't want me just to sign a receipt of release of the passports, she wanted me to sign a contract written by Jacob (attached in file), which is unfair because you where telling me at the telephone about a confirmation that both parties are ok with me having the passport for the travel. Plus we never sad I would just get one passport.

After geting advise of a lawyer and police it's my right to have the passport of my son.

I inform you kindly that the Australian passport stays with me until court decides something else! There is no risk at all that I want to leave back to Germany and I never gave any reasons for a doubt. I will sign a stat dec. to prove this.

Jacob informed me [REDACTED] is now on the airport watch list. I ask you to confirm that with an official document. If not, there is no reason why I can't have this passport but also that I can attend my holidays at Sunday. As the agreement was already established until I was being forced to sign a contract I didn't understand.

Also your receptionst scratched me and I was bleeding! I even called her after the incident to make sure she knows what's going on and to explain to her that Im just fighting for my rights. She was laughing and said 'I understand where you come from', she mentioned nothing about abused at all!

[REDACTED] was at child care at this point of time he is well, I would never put him in harms way.

Jacob my husband got diagnosed with PTSD and is not stable at the moment. so it's probably normal for him to be worried about everything and extremely suspicious.

I'm waiting for your response.

Hopefully we get some parenting agreements in place and start acting like mature adults and in favour for [REDACTED]

This situation is extremely hard because I don't have family to support or speak the language perfectly!



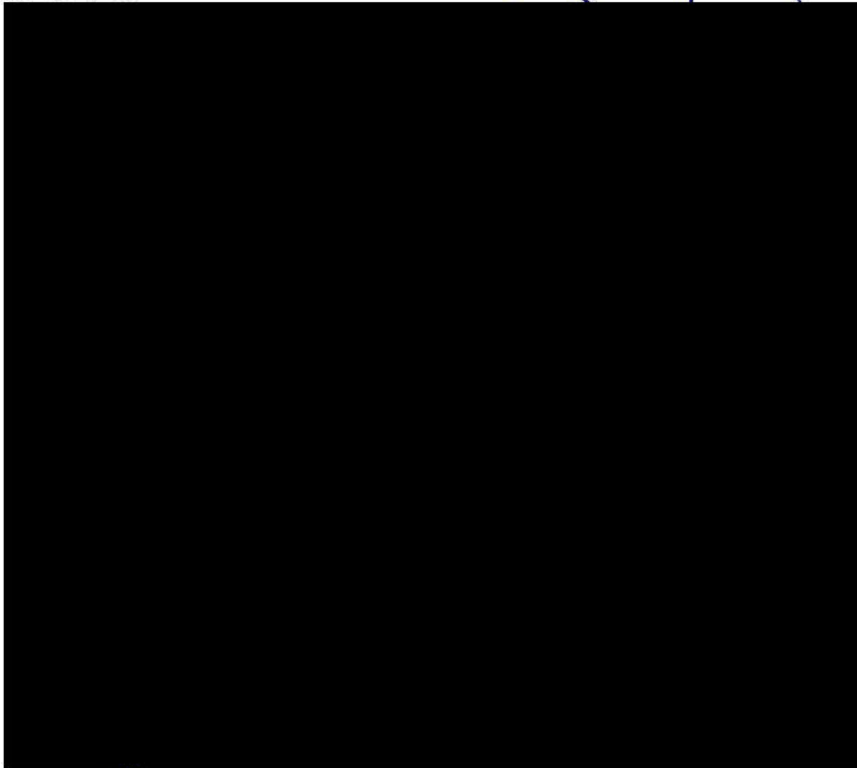
