**Segment 2 TEEN/ADULT Course Provisions**

1. Good Drivers Driving School Inc. will provide 6 hours of classroom instruction.
2. Good Drivers Driving School Inc. will supply all materials for class. \*Including organ donation information from Gift of Life Michigan\*.
3. Requirements for successful completion include mandatory attendance for the entire 6 hours and a passing score of 14pts or higher out of a possible 20pts on the final exam. Student is allowed to take a retake test. **No final classroom exam required for adults 18 years old or over.**
4. Upon completion of the course, the student will be issued a “Michigan Driver Education Certificate of Completion” attesting to his/her completion of the requirements that the Michigan Department of State has set for Segment 2 of the graduated licensing program. **NO certificate issued for 18 years or older.**

**TERMS**

The parent or guardian authorizes the student to take part in the program on the basis that the student meets the physical requirements specified by the law for issuance of a motor vehicle operator’s license. For a student to take part in Segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent/guardian (or parent designee) on a level 1 license, and there has elapsed a minimum of 3 months since obtaining the level 1 driving permit. The student must also show proper verification (permit and driving log of 30 hours) at registration or first day of class. The adult (18 years or older), parent/guardian agrees to pay the **\$75 fee** before start of course unless other arrangements have been made with GDDSI. The student is only guaranteed a position in the class when payment is made prior to start date of class. Should a student miss a class session for any reason including illness, it will be the student’s responsibility to schedule a make-up session with the business office for **a make-up fee of \$25** before a certificate of completion will be issued. **Lost certificates will be replaced for a fee of \$20. Behavior problems will result in automatic dismissal with no refunds.**
