### Meeting called to order at 6:32 pm by Paul.

**Approval of Minutes:** Meeting Minutes for August 20, 2025, Board Meeting were reviewed. A motion was made by Chris and seconded by Cheryl to approve the minutes. Minutes were approved.

**Treasurer's Report:** The updated Financial Statement for August 2025 was provided to the Board by Terry. A motion was made by Paul and seconded by Chris to approve the report. Report was approved.

**Architectural Control Committee (ACC) Report:** The ACC list was reviewed. Since the last meeting, no new projects were submitted, 1 project was approved, 1 project is in progress and 2 were completed.

#### **HOA Members' Open Forum:**

#### **New Business:**

- > Texas HOA Legislation: Discussed process to solicit candidates for the Architectural Control Committee. Must send out a solicitation notice to the members. Chris will send board members a copy of the new TX law. Chris will draft a solicitation notice. The board can approach members about being a nominee after the notice has been sent out.
- > TVEC's annual meeting: Discussed how to cast the HOA's votes for TVEC's board members. Terry made a motion to cast votes for the 3 unopposed candidates on the TVEC ballot. Paul seconded the motion. The motion past and Terry will cast the votes for the HOA.

#### **On-Going Business:**

➤ Curtesy Dock Replacement: Terry followed up with Pond Kings and their quote for a floating 4' wide by 40' long dock came back at about \$41,000. Paul and Cheryl will check on getting bids from dock builders to replace the existing wood dock.

- Fining Policy: Discussed the latest changes that have been proposed by Don, Chris and Terry. Will keep reviewing and submitting changes to further reflect the HOA's CC&Rs.
- **By-Laws:** Chris noted that we need to resume reviewing and updating the HOA's By-Laws. Chris will start working on a draft.

Paul made a motion and Terry seconded that the Board go into Executive Session at 7:50 pm.

Paul made a motion and Terry seconded to adjourn the Executive Session and return to the General Session at 7:56 pm.

**Executive Session:** During the Executive Session, the Board agreed to:

- Issue violation letters to 2 homeowners concerning the exterior maintenance of their property.
