## **MINUTES**

Dick Masten moved to approve the April Board of Director and General Membership meeting minutes. EJ Schinski seconded the motion. The motion passed by a majority vote of the Board.

## **REPORTS**

# **TREASURER**

Dick Masten reported on the financial standing of the Club, indicating that the April 2023 Revenue was \$82,727 and the Expenses were \$67,491, resulting in a gain of \$15,236 for the month. He further reported that several certified letters had been mailed out. Barbara moved to accept the Treasurer Report. EJ Schinski seconded the motion which was passed by a majority vote of the Board.

# **VICE COMMODORE**
