BOARD OF DIRECTORS MEETING MINUTES

The April 1, 2024, Board of Directors Meeting was called to order at 7:00 PM.

REPORTS

COMMADORE

Dave Kays reported that he is recommending that Miranda Singley move to the Treasurer position and Lloyd Sigrist be appointed as the Vice Commadore. Following Dave's brief explanation, he moved to make the reported changes to the Board. Barbara seconded the motion. Discussion amongst the Board Members involved whether or not the Board can make those changes without membership approval (per the by-laws, the Board can make those changes), the status on paperwork being processed by the new bookkeeping service (BAE) and straightening out insurance and vendor discrepancies and issues. Dave Kays and Miranda indicated that BAE representative, Jennifer, will be collecting mail, checks, invoices, etc. from the Pilot House twice a week. At this point in time, all checks received have been deposited and monies/charges posted to accounts. At the conclusion of these discussions, the question was called as to the motion put forth by Dave Kays. The vote was unanimous in favor of the motion. Miranda and Lloyd were sworn in as Treasurer and Vice Commadore respectively. Dave Kays reported that he is looking for an individual to serve as Seargent at Arms.

TREASURER

Miranda provided information relating to the office operations and the new bookkeeping service getting the individual member accounts and vendor accounts rectified and up to date. She further reported that she continues to get reports from the police detective assigned to the Club's case and that things are moving forward. Additional information will be provided to members when possible and appropriate.

SECRETARY

Barbara reminded the membership that the monthly newsletter is now exclusively being e-mailed out and also on the website.

Dave Plotnik reported that there had been an ACME day on Saturday, March 16 and he thanked those members that participated.

MEMBERSHIP

Jerry reported that 62 members were in attendance at the meeting, and that he has a few possible new members to join the Club next month.

He is looking at Loo Key in the southern Florida Keys area as a location. He further invited Rick Buckner to come forward and speak of the area of Central Florida around Lake Placid. Rick suggested that people speak to him directly about the area as there are a number of amenities in the area which makes Lake Placid a great destination.

COMMADORE

Dave Kays spoke of the kid's Easter party and thanked those that participated. He also stated that he would be meeting with a contact from the Marine Industry Group whom he was referred to by Jen Britt.

OLD BUSINESS

TREASURER

Miranda reported on the progress of the contracted attorneys with respect to meetings with the County and the lease agreement. Miranda stated that there is a current invoice pending in the amount of \$5,155. Barbara moved to approve payment of the invoice. Dave Kays seconded the motion. Prior to putting the question of payment before the membership, the Board voted unanimously in favor of the motion to make payment. The question was then put to the membership with questions taken by members. In a question posed by Rick Buckner, Miranda stated that the Club's monthly bills are getting paid and that in order to move forward, the attorney invoice should be paid. In response to member Mike Simms asking whether the attorney bill will be a recurring charge, Miranda stated that yes, there will be a bill from the attorney's as long as they are working on our behalf. Miranda and Dave Kays stated that the attorneys will also be working on grant and/or public funding opportunities, and that there is no definitive timeline as to when the issues may be resolved. Following these questions and discussions, a vote of the membership was taken which was in favor of paying the attorney invoice in the amount of \$5,155.

VICE COMMODORE

Lloyd reported that he had met with the attorneys and provided a brief overview of the meeting, believing that the attorneys progress with the County has been positive.

Dave Plotnik thanked Lloyd for bringing an electrical contractor to the Club to review the electrical work that needed to be done.

Dave Plotnik announced that there will be an ACME day on Saturday, April 13th.

He invited those interested in helping out to attend. Joe Kessling spoke about the need for raffle items and asked for donations of raffle prizes. Dave Kays stated that he would donate 2 Dolphin tickets and a parking pass for a prize. Lacey Mills spoke about the t-shirt design and sales that will go along with the tournament.
