- A. Mr. Brent Kessler highlighted the proposed 2020-2021 budget:
 - Total expenses would increase by \$40,462
 - Salary increase of 3.0%
 - Board members discussed possible \$100 per seat tuition increase

- D. Course Approval "Build Your Own Course"- this option allows students to work with a certified teacher to design a one-credit course. Mr. Donald Carl made a motion to approve the "Build Your Own Course" option, Mrs. Sue Heistand seconded, all were in favor, motion carried.
- E. "Accelerate Your Learning at Home" opportunity this option allows students the ability to take work home to speed up their work progress. Mrs. Sue Heistand made a motion to accept the "Accelerate Your Learning at Home" option. Mr. Donald Carl seconded, all were in favor, motion carried.

V. Action Items

A./B. Approval of Treasurer's Report and Approval of Bills - Mr. Brent Kessler reported that 26% of the budget has been used so far and all the September bills have been paid. Mrs. Sue Heistand made a motion to approve the Treasurer's Report and Payment of the Bills through September 2019. Mrs. Karen Baum seconded, all were in favor, motion carried.

C. Hiring of Biology and General Science Teacher, Mrs. Leslie Gentzyel for four (4) hours per week at \$35.32 per hour pending receipt of all clearances- Mr. Brian Hoffman made a motion to accept the hiring of Mrs. Leslie Gentzyel, Mrs. Sue Heistand seconded, all were in favor, motion carried.

VI. Coordinator of Student Services' Report (Mrs. Cynthia Tomevi)

A. Update of School Presentations/Experience days – Upcoming experience days include a visit to YTI Career Institute, York County School of Technology and Harrisburg Area Community College. A representative from MANTEC will visit YAA on November 19, 2019 to discuss a free advanced manufacturing training offered for high school graduates.

VII. Director's Report

A. Enrollment Report- Mr. Christopher Fultz reported that we have fifteen (15) graduates to date and four (4) of our students have one (1) credit or less to complete all their graduation requirements. Seventy (70%) of our seats are full. Total graduates to date: 4097.

VIII. President's Report
