REGALAMENTOS A SEGUIR / RULES TO FOLLOW PLEASE READ

Please read and sign

1. **HORARIOS/ TIMES:** Sat & Sunday 8am-8pm. Closing time may vary depending on time change and weather. You will have 1 hour to set up and NO CARS ARE ALLOWED in the customer area. AFTER 9:00 am 1 hora para configurar estar listo: para los clientes. ¡Llegue tiempo para que pueda entrar en su espacio y fuera del área de clientes no aceptan carros después de las 9:00am. (los puestos se daran forme vayan llegando para todos!) All canopies need weights on all canopy legs 20lbs or more, (Only food Vendor will be giving a permanent space . And may be moved if need by La pulguita staff) spaces are first come first serve.

2. **BASURA/GARBAGE:** Todos tenga su bote o bolsa de basura y cambie su bolsa de basura constantemente si vendes comida mínimo dos botes uno en cada lado de tu puesto. Deja su puesto limpio y barrido no deje corcholatas de las sodas cuando se retire al fin del dia. lleve su basura al recipiente autorizado Por el Mall. Have your garbage cans and change your garbage bag constantly if you sell food a minimum of 2 cans 1 per each side of your canopy or food truck or trailer and leave your space clean and swept from any debris and sodas caps at the end of your day.

3. **MULTAS/FINES:** Se les multara si dejan daños a la propiedad del Mall/there will be fines if you leave damage mall property in anyway. Its Illegal to dump cooking oil on parking lot or drain hole you will be band from La Pulguita and Outlet Mall

4. **VENEDORES DE COMIDA/ FOOD VENDORS:** Tienen que tener carpa en el piso para no dejar daños de grasa en la property permiso de comida valido acuerdo a lo que vendan y su tarjeta de alimentos a la mano aseguranza para ser aprobado. food vendors must have a valid food permit and have food handlers card in hand! No handmade signs unless you have art talent, banners for your promotion of your business are required. NO 8x10 slanted leg canopies allowed KEEP YOUR ITEMS IN THE SPACE YOU ARE PAYING FOR. YOU WILL PAY FOR THE EXTRA SPACE. NO early tear downs 6:00pm will be okay unless there is still customers walking around. if you are reminded not to tear down early without personnel permission.
